Call To Order:

Karn Stiegelmeier, Chair, called the joint NWCCOG Council/Economic Development District (EDD) Board meeting to order at 9:34 a.m. Roundtable introductions were completed, and a quorum was present for both groups.

Approval of NWCCOG Minutes:

Suze Kanack, Town of Walden Tom Clark, Town of Kremmling

M/S/P Patti Clapper/Tom Clark to approve the July 28, 2016 NWCCOG meeting minutes with the following revisions: correction on the Mayor of Walden's name and Jim White's jurisdiction to Grand Lake.

Approval of EDD Minutes:

M/S/P Suze Kanack/Diane Butler to approve the May 26, 2016 EDD Board meeting minutes as presented.

NWCCOG July 2016 Financials:

The Colorado Bark Beetle Cooperative (CBBC) will remain listed as CBBC on the financials until CBBC legally changes their name to High County Forest Collaborative.

M/S/P Suze Kanack/Jim White to approve the July 2016 NWCCOG financials as presented.

EDD July 2016 Financials:

M/S/P Corry Mihm/Jack Taylor to approve the July 2016 EDD financials as presented.

2015 Independent Audit Report:

Company piloting the audit, Plutt Rogers & Company PC, has not yet sent us any version of the audit despite our best efforts. The audit is due September 30, 2016 with no option to file for an additional extension. The Council agrees to have NWCCOG's attorney send the audit company a letter terminating our relationship and notifying him that he will receive no funds. Mike Kurth has identified a new firm and will get them started to complete the 2015 audit as soon as possible. We will send out an RFP for next year's audit services.

M/S/P Suze Kanack/Patti Clapper to have NWCCOG's legal counsel send a letter to terminate NWCCOG's relationship with Plutt Rogers & Company PC effective immediately due to failure to provide requested audit services.

M/S/P Patti Clapper/Suze Kanack to authorize staff to engage with an alternate auditing firm to complete the 2015 audit.

Program Updates & Proposed Activity for 2017:

- Broadband Project Planning, Nate Walowitz: The current Broadband grant expires at the end of June 2017. The next grant application is due by December 1, 2016. Greg Winkler believes that the proposed three-year broadband plan is broad enough and speaks to exactly what the state is looking for in a grant application. In this particular case, letters of endorsement from member jurisdictions will be important. M/S/P Patti Clapper/Corry Mihm to approve moving forward with the broadband grant application for three years and authorizing a 25% match.
- Small Business Development Center (SBDC), Rachel Lunney: The current model for the SBDC has been unrealistic and unsustainable. As this is a state developed program, it was proposed that NWCCOG develop a proposal to alter the SBDC program and create a model that works in our rural region. A committee was formed to help strategize the propsed reconfiguration of the SBDC program for the northwest region. The committee members are Chris Romer, Jack Taylor, Rachel Lunney, Corry Mihm, and Diane Butler. M/S/P Tom Clark/Chris Romer to approve to discontinue hosting the SBDC as it currently operates as of December 2016.
- Regional Transportation Coordinating Council (RTCC), Susan Juergensmeier: The RTCC program is perceived by CDOT as being the top model for this type of program in Colorado. This program is going to continue to increase in necessity and popularity.
 RTCC recently applied for a Rides to Wellness grant in the amount of \$130,000, but will

not know the result of that grant application until September. Regardless, this program requires more funding sources to support the increase in users. Please send any of your grant/funding suggestions to Susan Juergensmeier or Tom Clark. RTCC will let the council know if it receives the Rides to Wellness grant. If they do not receive the Rides to Wellness grant, Susan and Tom will be approaching the counties for support. The next RTCC meeting will be held on October 5, 2016.

- Weatherization, Nate Speerstra: The weatherization team successfully accomplished their grant terms for the 15/16 grant year. Weatherization will experience a 30% cut in funding this state fiscal year, due in part to the recent Supreme Court decision regarding British Petroleum and severance taxes. Subcontracting work may be a solution to this shortage: the Crisis Intervention Program (CIP) is one option along with sub-contracting work through CORE, CARE, and CLEAR programs, which are all administered through Energy Outreach Colorado.
- Alpine Area Retired and Senior Volunteer Program (RSVP), CJ Grove: The RSVP program only provides fund for Eagle County. NWCCOG has met most of the goals established for the three-year award already and still have one and a half years remaining in the grant. The volunteer program is now expanding to all five counties with funding from the Alpine Area Agency on Aging and will focus on proving caregiver respite and handyman services, REST training to train the volunteer to train other volunteers, and recruit volunteers for the Homemaker Program.
- Alpine Area Agency on Aging (AAAA), Amanda Rens-Moon: The AAAA is starting a new state fiscal year. They are encouraging participation in material aid, dental, and vision programs, and organizing more outreach events for volunteers and dental assistance. They are also focusing on the Homemaker Voucher program, which provides a voucher to assist consumers 60 and older to pay for light housekeeping and chores.

Proposed Projects for 2017 DOLA Grant:

- Water Quality and Quantity Committee (QQ), Liz Mullen: QQ would like to build on their 2011 Water and Its Relationship to the Economies of the Headwaters Counties report due to unanticipated levels of growth across the state and the creation of the State Water Plan. They would request \$25,000 from DOLA and start listening sessions this fall to prepare for the study in 2017. The Western Conservation Foundation will supply some of the match in addition to time from QQ's contractors paid through QQ dues from the local governments.

M/S/P Patti Clapper/Tom Clark to approve applying for a DOLA grant to build on previous QQ study in the amount of \$25,000 with a dollar-for-dollar match.

Executive Director Search and Timeline:

The Executive Director job description is posted, and the deadline for applicants is September 12, 2016. The Executive Committee will get together right after September 12, 2016 to review

applications. The Executive Committee will meet again to interview top candidates. Greg Winkler is willing to assist the committee throughout this process. The Executive Committee will also schedule an exit interview with Liz Mullen before going through applications. Elaina Wiegand will post the job description on CCCMA, CML, and CCI. Elaina Wiegand will also send three separate Doodle Polls to the Executive Committee regarding the meeting dates for the exit interview, vetting of applications, and top candidate interviews.

Comprehensive Economic Development Strategy (CEDS) Update for 2017, Rachel Lunney: Rachel Lunney presented the draft Regional Action Plan for the CEDS including proposed draft goals, objectives, and actions. Board members provided feedback to be incorporated in the revised action plan that will be posted on the NWCCOG EDD website: http://nwcoloradobusiness.org/about/comprehensive-economic-development-strategy/ceds-update-2016/.

The final CEDS will be approved at the NWCCOG Council meeting on December 8, 2016. The finalized CEDS report is due to the EDA by December 31, 2016.

Continued Discussion of 2017 DOLA Grants:

The Council discussed a number of ideas for an additional DOLA grant project. Ultimately, they agreed to apply for \$30,000 to fund the mini-grant program and the match requirement will be met by the jurisdictions that receive mini-grants on a per project basis.

M/S/P Suze Kanack/Tom Clark to apply for \$55,000 DOLA grant with dollar-for-dollar match (\$25,000 for QQ and \$30,000 for mini grants). QQ has identified their match. Mini grant applicants will have to commit match as part of their application.

Member Updates:

Summit County, Karn Stiegelmeier: Summit County has several large properties to put housing on, but lack the funds to build the housing. There are initiatives regarding funding for construction on the upcoming November ballot.

Jackson County, Betsy Blecha: The Beaver Creek fire is still active. The county has a few initiatives on the ballot.

Town of Kremmling, Tom Clark: The town of Kremmling is experiencing another banner year for sales tax. All businesses on Main Street are full with no vacant buildings for the first time. They have the leanest number of public works employees that they have ever had, but everything is operating smoothly.

Summit Independent Business Alliance, Corry Mihm: The Colorado Governor's Tourism Conference is in Breckenridge September 14 – 16, 2016. They are adding the "Discover Your Gem's" component, so local areas can show what hidden assets are around the state. This portion will be on Friday, September 16, 2016 at the end of the day.

Grand County EDD, Diane Butler: Grand County received a REDI grant for Disney Way workshops and the Grand Lake Center. They have an upcoming public conference for nonprofits regarding the development of culture within an organization October 24 – 27, 2016. The Ski Train is coming back to Winter Park. All sales tax is up in the county. The new County Manager, Lee Straub, is starting Monday, August 29, 2016.

Town of Walden, Suze Kanack: The motels are all full to capacity with firefighters causing the tourists to be displaced. The town is worried everything will still be occupied when hunting season arrives. Suze Kanack submitted her resignation to the town.

Town of Basalt, Denise Tomaskovic: The Town Manager of Basalt has submitted his resignation but many in the community do not want him to leave and there is pressure on the Town Council to work out an arrangement that would result in his return to work. There is an attainable housing project (adjacent to Basalt High School) in the review process for 60 single family homes on small lots and 96 multi-family units, a four-room childcare facility, and public indoor tennis courts. This project requires annexation into the Town and has not yet received final approval for development.

• Added 09/09/2016: Denise submitted her resignation and will not be employed with the Town of Basalt following September 13, 2016.

Vail Valley Partnership, Chris Romer: Two new flights landed at the Eagle County Regional Airport. There are three ballot initiatives for the county. Vail Valley Partnership has been named Chamber of the Year by the Association of Chamber of Commerce Executives (ACCE).

Department of Local Affairs (DOLA), Greg Winkler: DOLA is in a new grant application cycle. The deadline for applications is September 6, 2016. There will be another cycle with a deadline on December 1, 2016. Because of the decline in extractive industries, the Energy and Mineral Impact Assistance Fund (EIAF) is down to about \$18 million a quarter and expected to remain there through August 2017. Now grants will be more competitive. Anyone looking to apply in the September 6, 2016 cycle should contact Greg Winkler beforehand.

Colorado Workforce Center, Jack Taylor: The Summit County unemployment rate is currently 1.4% allowing the centers some time to get ready for fall. They are organizing weekly workshops for job search strategies, resumes, and workplace expectations. They will also be hosting some worker's compensation presentations throughout the region. Please email Jack Taylor or your local workforce center if you are interested in learning more about the presentations. The Summit County worker's compensation presentation will be on September 13, 2016 at Colorado Mountain College in Breckenridge.

Pitkin County, Patti Clapper: Pitkin County is currently working on a river park project at the upper entrance to Basalt. They will start diverting water to put infrastructure up for the future water park. After some unexpected delays, the county will be moving to their new, temporary

location in the next 10 - 14 days. They have a ballot initiative regarding open space and trails. They will be having a public lands forum soon.

Town of Vail, Patty McKenny: Vail recently celebrated its 50th birthday. After a little traffic confusion, the I-70 project is going well and expected for completion by next year. They are renovating a golf course to be finished later this fall 2016. The town is working on a strategic plan regarding housing that should be ready by September 6, 2016. The Timber Ridge apartments have been rebuilt as Lion's Ridge Apartment Homes. The town did not pass the proposal to increase ski lift cost. Now they will be meeting with their partners to see what they can do about transportation and parking.

Town of Frisco, Deborah Shaner: Frisco's Main Street reconstruction is completed. They had a record in sales tax this summer. The Town Manager, Bill Efting, announced his retirement. The town has taken ownership of the Frisco Nordic Center.

Memorandum of Understanding Between NWCCOG and Upper Colorado Wild and Scenic Stakeholder Group

This MOU is made effective as of ______ by and between Northwest Colorado Council of Governments (NWCCOG), and the Upper Colorado Wild and Scenic Stakeholder Group (W&S SG).

- 1. **Purpose**. The purpose of this MOU is to establish roles and responsibilities for NWCCOG to serve as the fiscal agent of grants awarded to W&S SG as part of the wild and scenic rivers fund, C.R.S. § 37-60-122.3, from the Colorado Water Conservation Board.
- 2. **Agreement period & termination**. This MOU shall commence _____ and is effective until either party provides written notice of a desire to terminate this MOU. Upon termination, any resources shall be forwarded to the designated institution or party, less the fiscal sponsor's fees, as agreed to by both parties.

3. Duties.

- a. In support of W&S SG, NWCCOG agrees to:
 - i. Serve as a fiscal sponsor for W&S SG at an indirect rate of 5% per each funded proposal.
 - ii. Sign and execute on-time contracts with W&S SG consultants.
 - iii. Submit payments based upon terms of invoice.
 - iv. Assign NWCCOG and Water Quality/ Quantity Committee (QQ) staff to serve as staff support to W&S SG administrative needs as related to the fiscal management of grants (i.e., supplying documents needed to submit grant proposals, accounting and tax requirements of grants, etc.).
 - v. Maintain ongoing and timely communication with W&S SG leadership and consultants.

b. W&S SG agrees to:

- Submit any and all funding requests on behalf of NWCCOG, only after approval from NWCCOG according to its procedures for approval from either the Executive Director or the NWCCOG Council.
- ii. Submit any and all grant reports on behalf of NWCCOG, only after approval from NWCCOG.
- iii. Provide all grant details, deadlines, applications and reports to NWCCOG.
- iv. Submit consultant invoices.
- v. Maintain ongoing and timely communication with NWCCOG's Executive Director and QQ program staff.

4. Terms of agency.

- a. Contractors.
 - Any contractors hired are independent contractors with respect to NWCCOG, and not employees of NWCCOG. All contractors hired for W&S SG projects funded through NWCCOG must sign a contract with NWCCOG outlining the contractual relationship before NWCCOG will pay an

other such necessary equipment, supplies, and personnel to accomplish the successful completion of deliverables.

Dear Ms. Arnold and Ms. Manning:

As you know, Northwest Colorado Council of Governments (NWCCOG) has been serving as host organization to the Northwest Colorado SBDC since January 2014. The NWSBDC center serves not only NWCCOG's 5core, duespaying counties (Eagle, Grand, Jackson, Pitkin and Summit), but also serves the additional six counties of Routt, Moffatt, Garfield, Clear Creek, Gilpin and Lake.

Over the course of the last three years, NWCCOG has experienced significant challenges with the program. We have brought these challenges forward to Kelly Manning and the NWCCOG Council and Economic Development District (EDD) Board of Directors on several occasions. These challenges over the last several years of the program have included insufficient funding, too large a geographic region, and unrealistic fundraising requirements. We now have a vacancy in the Director position, and we do not want to set the next director up for failure. The model currently in place is unrealistic and unsustainable. It requires the director to provide services to an 11 county region and simultaneously fundraise the (at minimum) \$33,000 cash match. This model has proven over and over again to be unsuccessful in our region.

At the direction of the NWCCOG Council and EDD Board of Directors, we assembled a subcommittee – the "SBDC Improvement Committee" – made up of EDD board members. This subcommittee met on September 8th (see meeting notes attached). The following recommendations were made to make the SBDC program more sustainable in our region, and that would, if put into place, allow NWCCOG to continue to serve as host:

Possible Solutions Discussed:

- 1. Cut the region into two: make Region 12 and Region 11 two separate SBDC regions, both at the current funding level.
- 2. NWCCOG continues to be the host, but the new director is only to be focused on providing consulting services to the region. The director is not tasked with fundraising. Based on past years' expenses, and paying the director (contractor) \$55,000/year, the shortfall in funding is still projected to be about \$20,000. In this scenario the Lead Center would not require our region to raise the \$33,000 cash match; the Lead Center would make up the funding shortfall.
- 3. OEDIT to find an alternate private-sector funding source that will provide the \$33,000 cash match needed for our region.

At the time of this letter, NWCCOG has not received word that any of these solutions would be amenable to OEDIT. Therefore NWCCOG has no choice but to discontinue as host after 12/31/16.

NWCCOG believes the SBDC is a valuable, vital program in our region. We took on the role as host because we recognized that the programs and services provided by the SBDC directly fit the mission of the EDD in providing training, consulting, and technical assistance to our existing small businesses and those looking to start new businesses. However, under the current model, NWCCOG can no longer continue to serve as host organization after 12/31/16. I would be happy to discuss this with you at any time.

Overview:

Rachel welcomed the group. She explained that this committee, made up of NWCCOG Economic Development District Board Members, was put together the request of the NWCOG Council and the EDD Board during the August 25th board meeting to examine possible changes to the SBDC model such that it is more sustainable in our region. NWCCOG has served as host to the Northwest SBDC since 1/1/14. The challenges over the last several years of the program have been not enough funding and too large a geographic region. These challenges have proven to be too much for one staff person to handle. We now have a vacancy in the Director position, and we do not want to set the next director up for failure. The NWCCOG Council voted that NWCCOG will no longer host the Northwest SBDC after 12/31/16 under its current model. The model currently in place is unrealistic; non-sustainable. It requires the director to provides services to an 11 county region and the same time fundraise 50% of the time to raise the (at minimum) \$33,000 cash match required of each center across the state. This model has proven over and over again to be unrealistic in our region.

The group next focused on the core mission of the SBDC, and focused discussion on whether or not the current model is serving this mission. The mission of the SBDC is: "to helping existing and new businesses grow and prosper through free, one-on-one consulting and no- or low-cost business training programs".

Rachel asked each committee member to answer the following: What does your organization want to get out of the SBDC?

Grand County - DiAnn Butler

- Grand County does have an entity providing consulting services Grand Enterprise Initiative (Patrick Brower)
- Leading Edge Program biggest benefit
- The county can find other ways to provide business development; training
- Watched this program be started 3 times and not be sustainable
- Challenge for our region: too large a geographic region

- DiAnn works directly for the county, so her organization is not directly in competition for the same money being asked to match this program; this has been a challenge for other membership-based organizations like NWCCOG and chambers
- The SBDC is just one tool in the OEDIT "toolbox"; how do you leverage this in other rural communities; how do we leverage what we can realistically do in this region with the funding available
- We don't want to set the next director up for failure

Vail Valley Partnership – Chris Romer

- VVP was close to becoming an SBDC host; they looked at finances and walked away because they saw no way to NOT underwrite (i.e. fund) the SBDC
- There is a need for the business support services; but the current model requires a continuous focus on raising money for the SBDC vs. providing the services to businesses
- A new model needs to be more focused on the value; not chasing around fundraising over a huge region
- Current model encourages producing events to raise money; it becomes "how do we raise the funds, not how do we serve the businesses"; we don't have big corporations to write big checks in this region
- Chris put together some ideas for potential changes to the program (see Chris' memo attached)

Frisco Workforce Center - Jack Taylor

- Mission of the workforce center is to match businesses seeking to fill jobs with qualified applicants
- Business education is tough to get customers to come for because they are running their business; but there is a need for this training among businesses in this region
- Workforce center does refer people to the SBDC; those that are looking for work, can't find it, so want to "create" it
- NWCCOG EDD has a great opportunity to play a strong role question is how? What is that role?

NWCCOG - Liz Mullen

- Main reason NWCCOG agreed to host is because the Northwest Loan Fund just got started again (3 years ago) and needed somewhere to refer potential clients to for help with their financials and loan package; But in reality: NLF did not refer that much to the SBDC; Anita (NLF Director) did not have confidence in the program/qualifications of the consultants
- We inherited the director; Director assured NWCOG that she will raise all the match
- NWCCOG still needs access to qualified consultants we can refer potential loan clients to for help in putting together loan packages; SBDC could serve this role but seems to mostly serve a less experienced clientele.

Summit Independent Business Alliance/Summit Chamber - Corry Mihm

- Business education and consulting, during up times and down times, is always a need
- Education: categories: finance/marketing/operations/business practices/leadership and selfdevelopment
- Challenge to get people to show up to trainings
- Structure and model is a challenge

- SBDC doing the best job I've seen over the last several years; doing a good job pulling together all the opportunities are out there and make them available in once place; would be a shame to lose this momentum
- The large geographic region is a signification challenge
- Need to do an assessment of the assets in the region what is everyone doing
- Funding mechanisms chamber memberships; SIBA memberships competing for the same dollars; SBDC/other providers of business services don't "pull at heart strings"
- We don't have deep pocketed corporations that are going to write big checks in this region

Colorado Mountain College - Matt Gianneschi

- CMC has served as host from a facilities standpoint (i.e. provides office space; meeting/training space)
- CMC has no interest in owning another enterprise tangential to its mission
- CMC's role could be within offering non-credit classes; do a lot of different work in these courses: e.g. OSHA training; safety training for oil and gas workers; licensure renewal for police officers (industry specific) will provide these at no profit
- CMC does have a number of programs relevant to small business
- Need of CMC: to better understand the needs off the business community so that they can provide education / training relevant/needed by our key industries
- CMC did have a program whereby they offered non-credit business education; goal was that this
 program was meant to become self-sustaining through fees; but it was a money-loser and they
 did not continue it
- Find ways for the SBDC to help CMC fulfill its mission by doing it in a complimentary way; SBDC could help identify training needs of businesses, then could turn it over to CMC and they would provide the training. CMC can fulfill the role as "educator"
- CMC saw the very same thing with the financial challenges of the SBDC as did VVP and NWCCOG

Kelly Manning – State Director, SBDC

- SBDC does not have to provide 1/1 consulting to everyone in the state, regardless of whether there is a local host/center or not
- Training is for three purposes: get a lot of people in the room at a time; to weed out people that
 are not really serious about starting a business; earn funds to help support the center (raising
 funds)
- Finding funding that is sustainable for the program is crucial; this often comes from the host organization
- Created a new intake process it is streamlined; it is done on-line to weed out some people;
 SBDC is always working on developing more innovative ways of doing things
- Sweet spot: client with 3 5 years in business

Dick Pickett – Eastern Colorado SBDC. Dick was invited to participate in this meeting to give an example of a successful, large rural region in the state.

- 8.5 years in the job
- Came into a challenging situation
- The financial model has been a strain
- Started with just one county (Weld); now has 13
- Greeley is the largest city; have many small communities
- Went to every networking event where he asked everyone to come see him for consulting

- Tornado came through Windor; helped build momentum because of the need it created
- Have several Satellite offices who pay whatever they can afford to pay; have 29 satellite offices;
 a satellite office within 30 minutes from any business
- Did a lot of asking for money from towns and counties
- Did a lot of face to face visits with the communities
- No big corporations with deep pockets
- Largest sponsors are the host (UNC University of Northern Colorado) and Weld county
- \$400,000 to run the program
- \$135,000 grant from Lead Center
- Utilize work study students; now have a full time director and a full time admin person
- 4 full time consultants; 8 part time consultants
- 4 higher education institutions; they all put in money
- \$25 million in impact; 41 business starts
- Utilize an advisory board
- Fundraising using workshops provide them for free last year did 70 workshops
- 5-7 year track record now; sponsors step up the plate every year because they see the value in the program
- Donations are anywhere from \$500 \$40,000

Kelly Manning:

- SBA grant (\$65,000) and any host dollars should go ONLY to director salary
- Any funds raised should go to consulting or specialty services
- Every director's role is to fundraise
- Usually every host needs to put 'skin in the game' financially; Kelly did not require that of NWCCOG, which is not usual

Corry Mihm:

- Need to put into place short term stop gap measures; we have built momentum around the SBDC over the last 3 years; there is name recognition; we don't want to start over; we don't want to lose ground
- We need to come up with a model that is sustainable

Kelly Manning:

- Lead Center needs to make sure services are provided in this area regardless of whether or not NWCCOG continues to serve as host
- Kelly has put out a job posting for a new director on the national SBDC site
- You are not going to have a sustainable program without the fundraising
- Need a neutral host like NWCCOG; currently she has no other host options in our region; program would revert back to State office (in Denver)
- If every county put in \$3,000, that would be \$33,000

Chris Romer:

• Business Resource Model – works really well on a county-level

DiAnn Butler:

We don't want to set someone else up for failure (like previous directors in this region)

- Dick must have volunteered a lot of his time to make it work in that region
- DiAnn is disappointed by how OEDIT is doling out the SBA funding to run the SBDC program as it is underfunded in our large region
- Kelly stated that she inherited the statewide model in its current form

Possible Solutions Discussed:

- 1 Cut the region into 2: make Region 12 and Region 11 2 separate SBDC regions. Kelly said that then she would have to cut the funding in half as well.
- 2 NWCCOG continues to be the host, but the new director is only to be focused on providing consulting services to the region. The director is not tasked with fundraising. Based on past years' expenses, and paying the director (contractor) \$55,000/year, the shortfall in funding is still projected to be about \$20,000. In this scenario the Lead Center would not require our region to raise the \$33,000 cash match required of all centers in the state. Lead Center would make up the funding shortfall. Kelly said this is not an option, and that it is a requirement of every SBDC director to fundraise, and it is a requirement for every center to provide the (at minimum) \$33,000 cash match.
- 3 Find a funding source that will provide the \$33,000 cash match needed. This could include a benefactor, corporate sponsor, or a grant. Kelly will be in contact with Robin Haney from CMC who is an oil and gas expert to discuss potential funders in this industry. Rachel sent Kelly the USDA Rural Business Development Grant opportunity information as a possible source, however the deadline isn't until 1/27/17, and if funded would not see the money until earliest March 2017 most likely. Kelly asked committee members to forward her any ideas of possible benefactors and/or companies that she could talk to, and asked that we make the intro for her.

Next Steps:

The committee did not come up with a viable solution at today's meeting. Kelly suggested that this is a larger problem to solve in just 2 hours, and asked that we continue to discuss options for NWCCOG to continue to serve as host. The only viable solution appears to be to raise the cash match in advance of the start of 2017. If this happens, NWCCOG may continue to serve as host. If this does not happen, the NWCCOG will no longer host the Northwest SBDC center after 12/31/16.

The job posting is out on the national SBDC site as well as OEDIT site. Rachel will forward to committee members so that each can distribute via their channels (attached with these meeting notes). All job applications will go to Kelly Manning at the Lead Center.

The NWCCOG Council will be updated on this matter at the October 27th Council Meeting. If no changes are made to the program, and if NWCCOG will no longer serve as host after 12/31/16, a memo will be drafted to Kelly Manning and Fiona Arnold informing OEDIT that NWCCOG will no longer serve as host to the Northwest SBDC, and will clearly outline the reasons why. The memo will be reviewed by the Council first, then send to Kelly and Fiona.

The meeting adjourned at 5:30 p.m.



PROGRAM UPDATES

To: NWCCOG Council From: NWCCOG Staff October 19, 2016 Re: Program Updates

The following are the events of note that have occurred since the August 25, 2016 NWCCOG meeting.

Administration/Regional Business - Liz Mullen, Executive Director

- NWCCOG has engaged CliftonLarsonAllen LLP to complete our 2015 audit. Field work is being conducted in the NWCCOG office the week of October 17th. The final report is expected at the end of November.
- The draft 2017 NWCCOG budget was sent to the Council on Friday, October 14th.
- 2017 NWCCOG and QQ dues notices were sent to all members on August 23rd.

Alpine Area Agency on Aging (Alpine AAA) – Erin Fisher, Director

REST Training – The Alpine Area Agency on Aging, in partnership with the Summit County Community and Senior Center, hosted a train-the-trainer REST (Respite Education & Support Tools) event in Frisco, on September 8^{th} and 9^{th} . This training provided the tools and knowledge necessary for 5 attendees (across our region) to provide respite training to volunteers. This training is the foundation of Alpine AAA's new caregiver respite volunteer program, which we anticipate being an exceptional support for the many overwhelmed caregivers in our area.



National Lifespan Respite Conference – Amanda Rens-Moon, Program Specialist, attended the National Lifespan Respite Conference in Denver. This conference brought nationwide attention to the issues of caregiver burnout and need for respite. Highlights of the conference included video messages from Senator Elizabeth Dole, Rep. Jim Langevin (D-RI,) and Rep Gregg Harper (R-MS,) and Keynote Presentations from Percy Devine (Bi-Regional Administrator, Regions VI and VIII Administration for

Community Living,) Amy Goyer (AARP's Family and Caregiving Expert,) and Jane Barton (Speaker and Author.)

Ombudsman Training – Erin Fisher, Alpine AAA Director, and Shari Frye, Volunteer Ombudsman, attended a multi-day training in Denver during September. The event helped solidify ombudsman skills and knowledgebase.

Region-wide Presentations – Amanda Rens-Moon and CJ Grove, Volunteer Coordinator, are completing presentations at senior centers across the region to provide program information and recruit new volunteers. In addition, these presentations have provided an opportunity to better understand the unique needs of older adults throughout the region.

Magazine – The Alpine AAA recently completed the inaugural issue of the <u>Independent Living Times</u>, a new quarterly magazine designed to provide regional resources and information for area older adults. The magazine will be made available to senior centers, provided with home delivered meals, and delivered to area doctor and dental offices for their waiting rooms. An electronic version of the magazine will be made available at www.alpineaaa.org.

<u>Alpine Area Retired and Senior Volunteer Program (RSVP) —</u> C.J. Grove, Alpine RSVP & NWCCOG Volunteer Program Coordinator

Alpine Area RSVP (Eagle County only) – Our service numbers for the period of August 1st – September 30th are as follows:

We have a total of 131 volunteers

Capacity building – 2,037hours (the majority of these hours were worked at the Eagle Valley Community Fund Rummage Sale)

Education – 12.50 hours (After school meal program)

Healthy Futures – 1,167.80 hours (coaching/training classes, distributing information, preventing elder abuse, companionship, food delivery, transportation, food collection and congregate meals sites)

Other Community Priorities – 276.50 hours

Veterans transportation – 26.50 hours

Alpine Area Agency on Aging (Eagle, Grand, Jackson, Pitkin and Summit) — We are partnering with the churches in the region to recruit volunteers for the Caregiver Respite program. We have a partner in each county at this point with a potential of 40 volunteers for the program. We will begin training Respite volunteers in November.

<u>State Health Insurance Assistance Program (SHIP)/Senior Medicare Patrol (SMP)</u> –T.J. Dufresne, Health Insurance Assistance Coordinator

This month begins the Medicare Annual Enrollment Period for Medicare beneficiaries who have Part D Prescription coverage and/or Part C Advantage health care coverage. This is the only time of year they can change these two types of coverage for the following year. The majority of Medicare beneficiaries have Advantage plans and all beneficiaries who have Medigap plans must have Part D prescription coverage to avoid a penalty. This is the period of time we have the highest demand for assistance.

We have worked to recruit more volunteers in all of our five countries to help with the heavier Medicare assistance demand. We will have three active volunteers in Eagle County – one in Eagle, one in Minturn/Vail, and one in El Jebel. We will have four volunteers in Summit County with one of them not

working directly with beneficiaries until later in the enrollment period. We still do not have volunteers in Grand, Jackson, and Pitkin Counties. The SHIP Coordinator is serving those counties in addition to supporting Summit and Eagle Counties.

We have a list of people who are interested in becoming volunteers. However, there was a reduction in accessibility for new counselor training for almost a year due to the Medicare SHIP/SMP program being moved from the Department of Health and Human Resources to the Community Living Services Agency (CLS) which includes the Area on Aging division. The Community Living Services Agency has reworked the training and certification process in order for it to be accessible on-line. In the long run, it will be more accessible and reduces training costs. New certification training will begin as soon as CLS releases the online training modules.

There are education and open enrollment events including Aging into Medicare sessions planned through the end of the year. We will also partner with human resource departments to educate employees who are transitioning into Medicare or are already Medicare eligible – even for employees and/retirees who retain access to health care coverage with their former employer's coverage. Health Fairs are set to begin and there will be tabling at these events.

<u>Broadband Projects</u> – Nate Walowitz, Regional Broadband Coordinator

- Nate is conducting meetings throughout NWCCOG to share the objectives of the Regional Broadband Network project to local governments and partners.
- ForeThought submitted a proposal to the Colorado Broadband Deployment Board for the radio and site infrastructure for middle and last mile for Red Cliff at the Ski Cooper Site. Buildout is scheduled for Spring/Summer 2017. ForeThought was awarded the grant. CenturyLink has the right of first refusal available to it through October 13th. Red Cliff has submitted an application to the USFS for a communications site at Ski Cooper. Construction on the Red Cliff tower is complete. Xcel power pole placement and running lines is still in progress. NWCCOG, Red Cliff, ForeThought and Mammoth Networks are working with Ski Cooper, to use for ski lift terminal structures as mounting locations for poles to host microwave antennas for links from Red Cliff to Ski Cooper and Ski Cooper to Mosquito Pass
- Mammoth Networks is working in Grand County to enable fiber broadband services to a number of businesses in Tabernash.
- Pitkin County has submitted a grant application for buildout of three mountaintop microwave system and reconstruction/enhancement of existing county owned tower sites for broadband and DTRS radio sites.

- Adams Tunnel Fiber Project will be built in Fall/Winter 2016/2017. CenturyLink has interest in using this connection to deliver redundant path bandwidth to/from Estes Park and Grand Lake.
- While this issue is still exists, Eagle County has partnered with Mammoth Networks to provide a 10 Gbps alternate path at very competitive pricing. This broadband network path is available at the Eagle County Government Center in Gypsum.
- CenturyLink is installing fiber along U.S. 40 in Fraser in support of CAF 2 deployment.
- Mountain Parks Electric has contracted with a consultant to investigate FTTH.

<u>High Country Forest Collaborative (HCFC) (formerly Colorado Bark Beetle Cooperative)</u> – *Abbie Cobb, Coordinator*

The HCFC will host the 2016 Colorado Forest Collaboratives Summit on October 24, 2016 in Keystone. This is a meeting of all of the forest collaborative organizations to discuss what each organization is doing and educate them on how best to work with the state and federal forest services.

Economic Development District (EDD) - Rachel Lunney, Director

CEDS Update: The CEDS document and web site development are well underway. The draft regional action plan, based on extensive input from county-level SWOT meetings, review of existing planning documents, and participation in other on-going planning efforts throughout the region, has been reviewed and edited. The new CEDS website is being populated with data and text. The draft document and web site will be presented at the next NWCCOG EDD Working Group meeting on Wed. October 26^{th} from 1-4 pm at CMC Dillon. Rachel Lunney presented on business resources available in the region at the Employment First seminar on June 21st offered by the Summit County Department of Human Services. Rachel will present on Summit County Economic Trends at the Land Title Coffee Talk on November 16th. Rachel presented on Eagle County Economic Trends at the Vail Valley Partnership's Business Forum on September 14th. On August 2nd, Rachel served on a panel at the EDA Denver Regional Conference on demographic trends and how they affect the regional economy. The September 2016 Regional Quarterly Economic Update (based on Q1 2016 QCWE data) was sent out on September 2nd with a 28% open rate. Rachel provided a Region 12 demographic/economic update to State Demography Office for the annual demography Summit to be held on November 4th in Arvada.

WorkWell Collaborative – the WorkWell Collaborative has completed Year 1 of its grant as of 6/30/16. This is a 3-year grant from the Colorado Department of Public Health and Environment; the main grantee is Eagle County Public Health. NWCCOG's main role is to convene a regional advisory committee to oversee the initiative, and to conduct marketing and outreach. Rachel Lunney and Katie Haas will be presenting the idea of making worksite wellness a sub-committee of the Rural Resort and Northwest Region's Workforce Development Board, since these governing bodies mirror what we are trying to accomplish with the regional advisory committee – i.e. made up of representatives from the key sectors of our economy. Katie and Rachel will present this idea to the WDB on October 19th.

EDA – Economic Adjustment Assistance grant for Grand/Clear Creek Counties. The grant in the amount of \$100,000 (matched by \$100,000 from Climax Molybdenum) has been awarded. The grant funds will be used to hire a contractor to conduct a study of the economic impacts of the imminent closure of the Henderson Mill and Mine in those 2 counties. An RFP has been published to hire a contractor for this project. The RFP is posted on the NWCCOG EDD website here: http://nwcoloradobusiness.org/resource-center/rfps/. Proposals are due by November 11th; work will be getting underway by early 2017. The project's end date is November 30, 2017.

SBDC – at the NWCCOG Council/EDD Board meeting on August 25th, it was directed that an "SBDC Improvement Committee" be put together to explore alternatives for making the program sustainable in our region. This committee met on September 8th. Members of the committee: Chris Romer, Vail Valley Partnership; Corry Mihm, Summit Chamber; DiAnn Butler, Grand County Economic Development; Jack Taylor, Frisco Workforce Center; Matt Gianeschi, Colorado Mountain College. Kelly Manning, State Director for the SBDC and Liz Mullen and Rachel Lunney from NWCCOG also participated in that meeting. Based on the feedback from that meeting, a letter has been drafted to Fiona Arnold and Kelly Manning from OEDIT outlining our recommendations. This is an agenda item on the October 27th NWCCOG Council meeting agenda. Unless our recommendations are honored, the letter states that NWCCOG will discontinue as host of the Northwest SBDC as of December 31, 2016. We will continue to promote the SBDC's programs and services, and will partner as appropriate.

OEDIT Blueprint 2.0 Technical Assistance Program – NWCCOG has been awarded an OEDIT Blueprint 2.0 technical assistance grant for "Incubator/Accelerator Best Practices". The award is not cash, only technical assistance through OEDIT. We intend to send a team from our region to visit a successful project in the state. We are requesting to visit the Telluride Venture Accelerator and Southwest Innovation Corridor, so that we can learn best practices to bring back and hopefully implement in our region. Kelly Manning is the point person from OEDIT who is coordinating with

NWCCOG. We are looking to have a stakeholder planning meeting this November, and conduct the field trip in the first quarter of 2017. We intend to do some follow-up in the form of a workshop or meeting to share what we learned with the region.

Conferences/meetings: Rachel Lunney, EDD Director, will attend the following upcoming conferences: Economic Development Council of Colorado (EDCC) in Vail October $17^{th} - 19^{th}$; State Demography Office Annual Meeting in Arvada on November 4^{th} .

<u>Elevator Inspection Program (EIP)</u> – Steve Allen, Director

The Elevator Inspection Program is current with the annual inspections while increasing the number of 5-Year witnessing tests. We are also current on new construction and modernizations as well. To date, 130 permits for new or modified units have been issued in 2016.

Energy Management (Weatherization)- Nate Speerstra, Weatherization Program Specialist September marked the end of the first quarter of our 16/17 grant. Production numbers have been coming into line with our planned production. We got off to a slow start largely because of a bottleneck due to refrigerator contracting and delivery. We completed 14 units in the first quarter compared to the planned production of 23. In October we will have 29 units completed compared to our planned production number of 32 and looking into November we should have 50 completions which puts us ahead of planned production by 8 units.

The Weatherization Department has entered into a contract with Energy Outreach Colorado (EOC) to provide emergency heating repairs through the Crisis Intervention Program (CIP) that EOC administers for the Low-income Energy Assistance Program (LEAP). In addition to the entire territory that we serve for the Weatherization Assistance Program (WAP) we have picked municipalities that are adjacent to our WAP territory. Places like Conifer or Florissant or Central City are all very close to our current territory and will be serviced from our Silverthorne offices. We have already responded to two emergency no heat calls successfully, and with winter almost upon us, we are gearing up for our new role in first response heating emergencies.

We have met with all four of the nearby CARE program providers and have started two of their projects with several more coming on line this month. We look forward to cementing our reputation in energy conservation in all its forms and we are excited about the potential to provide weatherization measures to more households in our territory.

Northwest All Hazards Emergency Management Region (NWAHEMR) – Kim Cancelosi, Coordinator Purchases under the 2016 Homeland Security Grant Program are now permitted. The applicants whose proposals were awarded are in the process of securing competitive bids. The projects included under this grant are (1) Regional coordination and meetings, (2) Credentialing equipment for the region and for Grand Junction's mobile command center, (3) Regional Portable Corrals for large animals, (4) Public works mobile light/generator plants, and (5) Funds towards the McClure Pass Microwave Link system.



Throughout the summer there were numerous exercises and drills conducted. Later in October the County Animal Response Teams (CART) throughout the region will have a drill to practice tagging "pets" with their registered owners. Crates purchased with grant funds and the registration process will be utilized. Later in the day, the owners will come back to retrieve their pets. In preparation of this drill, Frisco Elementary School second graders from Ms. Heidi Sodetz's class collected 84 stuffed animals to be used as the pets for this drill and future drills and exercises.

Monitoring of equipment purchased with Homeland Security Grant Funds is under way. To date, Mesa, Moffat, Rio Blanco, Eagle and Routt County have completed the process. The other Counties will be monitored throughout October and November.



Northwest Loan Fund (NLF) - Anita Cameron, Director

Two loans have been funded. The Loan Committee met in person and toured a business that the NLF funded in Steamboat Springs. Anita has been on the road, with meetings, the business statewide Loan Fund Managers conference and teaching Loan Application classes at Colorado Mountain Colleges.

Regional Transportation Coordinating Council (RTCC) – Susan Juergensmeier, Mobility Manager
The new GEM (Garfield, Eagle Mesa) Connector service is now operating. The GEM Connector is a collaborative effort between ECO Transit, The Traveler, veteran's service officers and the NWCCOG Mountain Ride Transportation Resource Center to transport clients to and from medical appointments and other necessary services in Grand Junction.

For the first eight months of 2016 we have coordinated 5,448 one way trips. During the same time in 2015 we coordinated 3,237 trips.

Laurie Patterson will be leaving her position as Mobility Program Assistant at the end of October. She has accepted a position with another agency. In her time working at the call center she has been an invaluable part of the development of the Mountain Ride Transportation Resource Center. Her work on the call center has been appreciated and we wish her the best in her new position.

The next Regional Transportation Coordinating Council (RTCC) meeting will be held on December 7, 2016.

<u>Water Quality and Quantity Committee (QQ)</u> – Lane Wyatt and Torie Jarvis, Co-Directors QQ held its most recent board meeting on October 6th in Steamboat Springs. Despite waking up to snow all over the region, it was a great, well attended meeting. Members learned about work going on in Steamboat and Routt County as well as discussing much of the work going on with QQ currently. A copy of the agenda and board packet are available <u>here</u>.

QQ has been participating in a series of meetings along with state and federal regulators to examine potential ways to develop a more efficient NEPA process. Lane Wyatt is representing QQ and Watershed Services, and NWCCOG is the only local government regulatory entity represented in this process (and many QQ members advocated vehemently to ensure local governments were included in these meetings). Because many of the participants are not as familiar with local government 1041 regulations, QQ created a table that compares common or example 1041 permit criteria to other permits required by state and federal agencies. The table then shows submittal requirements for 1041 permits compared to EIS and other permit submittal requirements. This will be a valuable education tool in the future as well. The table is available in the board packet, linked above.

Funding for boat inspections that prevent the introduction of aquatic nuisance species like quagga and zebra mussels has been steadily declining in the past couple of years. To make matters significantly worse, a recent Colorado Supreme Court case significantly reduced available severance tax spending, meaning that funding for the boat inspection program for 2017 and onwards is completely gone. Due to the successful boat inspection program to date, Colorado is one of few Western states without an infestation in any of its lakes and reservoirs. QQ has been a leader in advocating for increased funding from state and federal agencies and will continue to work on this importation issue.

QQ is looking forward to working with NWCCOG to commission an update of it's 2011 study, Water & Its Relationship to the Economies of the Headwaters Counties, along with an update of QQ's Model Water Quality Standards & Definitions from the 1990s during 2017. Thank you to NWCCOG for your support!
