## **Olive Ridley's Coffee & Tea - Another Northwest Loan Fund Success!**



For 15 years, Natalie Wilson, currently of Rifle, CO, had a dream to open her own Coffee Shop - but life just got in the way. With 6 children, the timing was never quite right, until a few months ago. After her youngest finished high school, she and her husband took time off to travel and surf. Having spent almost a year living in Costa Rica, she fell in love with the simple, laid-back lifestyle. On a surfing trip to Nicaragua, she and her husband went into an eclectic coffee shop that created exactly the kind of great vibe she'd dreamed of with her own coffee shop.

"It was like the universe was telling me, now is the time," she said. She described the coffee shop as being warm, inviting, and exactly the kind of place people went to just spend time. Returning to Rifle, Natalie searched for just the right spot, and found it in the basement of 228 Railroad Avenue. Natalie was able to see past the deterioration to the potential for the amazing vibe she wanted.

Natalie worked with the Economic Development Committee who were very excited with her plans. With seed money from the EDC, Wilson still needed additional funds to finish creating her dream.

She was then introduced to Anita Cameron, Director of Business Lending of the Northwest Loan Fund (NLF). Anita encouraged Natalie to put the finishing touches on a loan application package.

"Anita made me think really hard and asked so many questions, that by the time we were finished, I had a much more solid plan," Wilson remarked. "She inspired me to keep going. She is driven to make sure everything is going to work." Wilson thinks Cameron is one of the most business-savvy women she's worked with.

The emphasis of the shop is on fresh, locally sourced ingredients and unique blends. You won't find mass-produced coffee at Olive Ridley's. In fact, Cameron says, "Natalie's signature coffee is well worth the 3 hour drive to Rifle."


Asked how she came up with the name, Wilson explained that Olive Ridley is a species of easy going sea turtle that nests off Costa Rica - thus the distinctive logo.

## **Board Member Spotlight John Hoffman**

Like many NWCCOG Board members, Carbondale Trustee, John Hoffman wears many hats. He's the town liaison for the NWCCOG, CDOT, and Senior Matters. He's on the Early Child Board, the Crystal Valley Environmental Protection Association, he is an alternate for the Roaring Forks Transit Association (RFTA) Board, and Chair of the West Elk Loop Scenic and Historic Byway Steering Committee. He's been associated with the NWCCOG since taking office in April of 2008. During the past 6 years he's served on the executive board, the director search board, and is the vice-president of the Rural Transportation Coordinating Council (RTCC).

When asked what he thought people might be surprised to learn about the NWCCOG he replied, "Elevator inspection is not on the radar for most people. The stealth weatherization program quietly improving the energy efficiency of the region is a surprise for many too. Also how many understand the vital dynamic that QQ (Water Quality and Quantity) brings to the water resources in this vast mountain region. In fact I think the incredible variety and range of programs the COG offers would be a revelation to just about everyone."

He thinks the best thing about the NWCCOG is the people. "The people are amazing, generous, funny and kind. They care about the region and work hard to represent it by obtaining services and infrastructure that will see us into a healthy future. The country we get to travel in to meetings is some of the prettiest in the world with the seasons bringing as much dimensionality as does the diversity of socio-economic and cultural settings. It makes me realize how satisfying it is to be here."

In his spare time, John loves walking mountain trails in the summer, winter, and fall. He's also an avid rafter, boater, diver, and sailor. He and his wife enjoy traveling and backpacking.
