Call to Order:

Karn Stiegelmeier, NWCCOG Council Chair, and Thomas Clark, EDD Board Chair, called the joint NWCCOG Council & EDD Board meeting to order at 10:17am. Roundtable introductions were completed, and a quorum was present for the group.

Approval of 10/27/16 NWCCOG Council Minutes:

M/S/P Patti Clapper/Jeanne McQueeney to approve the 10/27/16 minutes with 4 typo changes as noted in the motion.

NWCCOG November 2016 Financials:

Sarah Wyatt, Town of Walden (phone) Thomas Clark, Town of Kremmling

M/S/P Thomas Clark/Kristen Manguso to approve the November 2016 NWCCOG financials as presented.

2015 Independent Audit report presented by Paul Niedermuller & Erin Miller from Clifton Larson Allen:

Conducting an audit is not simply about verifying numbers; it has everything to do with internal controls and systems in place. The audit team had no scrutiny to report for the Weatherization program this year. As the Northwest Loan Fund program continues to increase, NWCCOG is recommended to increase monitoring the amount of collectability. There were no new accounting policies implemented by NWCCOG in 2015. There were no findings Clifton Larson Allen considered to be material weaknesses. Two items they did include in the management letter are as follows: how the financial statements are prepared and the segregation of duties. Due to the size of NWCCOG, Clifton Larson Allen did note that it is impractical to have perfect segregation of duties. The audit team recommends NWCCOG continue oversight of credit cards and checks that go out. They were appreciative of Thomas Clark's monthly review of checks and the council's review of financials in the meeting packet.

M/S/P Thomas Clark/Anne McKibben to approve the 2015 Audit as presented for submission to the state.

2016 Budget Revisions:

Jon Stavney, NWCCOG Director, summarized changes since first draft was submitted to council. *M/S/P Kristen Manguso/Jeanne McQueeney* to accept the 2016 budget revisions as presented for submission to the state.

Proposed 2017 Budget:

Jon Stavney, NWCCOG Executive Director, summarized changes since first draft was submitted to council. For the 2018 budget, Jon is going to work with Mike Kurth, NWCCOG Fiscal Agent, to reformat budget.

M/S/P Thomas Clark/Patti Clapper to accept the 2017 budget with the modifications on pages 34 and 36.

2017 NWCCOG draft meeting schedule:

The council approved the January 2017 meeting date as January 26, 2017. Elaina Wiegand, Office Manager, will schedule meeting time and place for remaining 2017 meetings for approval in January.

Title VI Civil Rights Complaint Policy:

CDOT requires that all of their grantees have a Title VI plan. In 2013, the council approved that particular portion of the Title VI policy. CDOT wants us to add/update the plan as seen in the addendums 1 and 2 in the board packet:

Addendum 1 outlining what CDOT wants to add to our plan; and Addendum 2 showing that we added a translation system, CTS LanguageLink, where Mountain Ride callers are provided more language options. CDOT requires proof of council approval for addendums 1 and 2.

M/S/P Anne McKibben/Jeanne McQueeney to approve revisions to NWCCOG Title VI Civil Rights Complaint Process and Form.

<u>Increase Elevator Inspection Fees – Memo from Jon Stavney, Executive Director:</u>

Jon Stavney reviewed reasons for increased fees noted in memo. There was a question regarding consultation fees which have since been removed from schedule.

M/S/P Patti Clapper/Thomas Clark to approve the elevator inspection fee schedule for 2017.

<u>EDD Bylaws – Memo from Rachel Lunney, EDD Director:</u>

Rachel Lunney walked the council through the EDD bylaws memo within the council packet. This will be on agenda for final approval at January 26, 2017 meeting.

<u>Presentation: Comprehensive Economic Development Strategy (CEDS) report website overview by Rachel Lunney, EDD Director:</u>

Rachel Lunney walked council through the website. This will be on agenda for action by EDD Board at January 26, 2017 meeting. 30 day comment period begins December 15, 2016.

<u>Update on potential fiscal agency to the Learning By Doing (LBD) Cooperative Effort in Grand County – Memo from Torie Jarvis, QQ Co-Director:</u>

LBD is considering asking us to act as fiscal agents for approval in January. This would fit into what we on working on with Water Quality and Quantity (QQ) and with our role on the 208 plan. There were no objections.

Program Updates:

- **Northwest Loan Fund, Anita Cameron**: Anita recently hired a part-time assistant due to her workload and allowance in NLF budget.
- **Broadband, Nathan Walowitz**: Broadband is primarily focused on their partners and supporting their partner's projects. Broadband then looks at how to regionally support partner projects and expand those opportunities.
- Regional Transportation Council (RTCC), Susan: RTCC continues to coordinate a multitude of trips in the 8 counties they serve (larger reach than NWCCOG 5 county region). CDOT approved the extension and match for the Veteran's grant: Veteran's Transportation and Community Living Initiative (VTCLI). RTCC received the Mobility Management contract for 2017 from CDOT. They also facilitated almost twice the amount of rides compared to last year.

Member Updates:

Pitkin County, Patti Clapper: Open Space and Trails initiative passed in November. Pitkin County was awarded their first Energy Impact Grant from the Department of Local Affairs (DOLA) and is ready to implement an extensive broadband and public safety initiative that includes more towns.

Town of Eagle, Anne McKibbin: The town is on schedule with the white-water park, Eagle River Park, project. They passed the ballot initiative last April to fund the park development. Eagle is in need of a second water treatment plant. The town is also embarking on their first "vision mission goals" strategic planning with the help of outside consultants. The idea is to develop big picture guidance for all other plans.

Town of Frisco, Deborah Shaner: The town recently hired a new Town Manager, Randy Ready. Frisco is focusing on their work with Summit County for the water study and housing crisis. There is an outpouring of concern regarding the housing shortage from small businesses due to the issue's detrimental impact on our workforce.

Town of Kremmling, Mark Campbell: Kremmling is reporting another record year for sales tax. They plan to pave some town streets in 2017. The town recently enrolled their employees in ambulatory and helicopter insurance since they live in a highly remote area. Coverage includes everyone in their household for only \$99 per person. Contact Mark Campbell, Kremmling Town Manager, if you are interested in learning more about the group providing this insurance.

Town of Red Cliff, Jake Spears: Red Cliff now has a tower up for broadband. Hopefully, they have full broadband next summer. Recently, all properties (buildings and roads) were surveyed.

Colorado Workforce Center, Jack Taylor: Unemployment is hovering right about 2% in Summit County; with 465 open job postings in the county, there are not as many unemployed people to fill those positions. Housing is a huge challenge causing businesses to limit operations. The Workforce Center has a job training program that could reimburse business up to \$3,000 for new employees that need training to get up to speed on the job they are entering. Many individuals do not have all of the skills necessary for job success on their hire date and this program will help them get a good start. However, the employee is required to have been unemployed beforehand.

Summit County, Karn Stiegelmeier: A sales tax increase to help fund housing construction passed in November. The county will be deciding on how to use that funding to best help the individuals who need housing. They are currently working on a suicide reduction program due to the higher rate of suicide in resort regions. Lastly, Summit County is participating in the "Take Back Pharmaceuticals" campaign. The Town of Dillon has already established a "Take Back Box" to drop unused pharmaceuticals. A pharmacy in Frisco is next to put up a drop box.

Town of Dillon, Carolyn Skowyra: Dillon is looking for properties to help with the housing issue. They passed the resolution to approve a sales rebate for REI (will be replacing space Sports Authority previous occupied). The budget for next year, which includes getting a loan to reconstruct Dillon Amphitheater, was approved. After July 4, 2017 the Amphitheater will shut down until July 4, 2018. The town is joining Silverthorne for health-screenings in January. Dillon is making plans to redo the town park. They are also experiencing some water challenges from the pipes (not the water source) in people's homes. Dillon is working to decrease the corrosion in the pipes of old homes as one solution.

Grand County, Kristen Manguso: Grand County lost their Colorado Supreme Court case against the YMCA camp, which applied for tax exempt status in 2004. It is a very large property, now officially off the tax rolls, so Grand County needs to refund them. Their open space trails and water initiative passed in November. The new county manager, Lee Staab, is transitioning well and taking the county in the right direction with the creation of a strategic plan for hiring.

EDD Grand County, Diane Butler: Grand County is excited about the community resiliency RFP which NWCCOG, Grand County, and Clear Creek County are working on together (the selection for the economic development consultant has been made since). Second, the Grand Plan, a 5-year strategic plan led by the BOCC is kicking off in January 2017 and that process will drive the mission, vision, goals, and objectives for the county. Also, through a separate grant from Freeport Mac Moran, Grand County's cohort for the sustainable community initiative has chosen to focus on affordable housing through a process led by Load Star consultants (Lake and Clear Creek Counties have chosen the same topic for the same process in their communities). They are looking closely to utilizing the Orton Family Foundation "Community Heart and Soul" process for stakeholder engagement during the Grand Plan just as the City of Golden and North Fork Gunnison Valleys have.

Town of Kremmling, Thomas Clark: the town is updating their water master plan which has not been changed since 2002. To help, they hired Applegate group as consultants, the water engineers who are specialists in that field and completed their plan in 2002. Kremmling has the tallest Christmas tree in the state rising 65 feet with 3,600 LED lights.

Eagle County, Jeanne McQueeney: Castle Peak Senior Center opened and is enrolling residents. The center is also passing their inspections and receiving their certificates. Neither the housing or open spaces initiatives passed in November. The Eagle County Finance Department was awarded a Certificate of Achievement for excellence in financial reporting by the commissioners. They were also named "Assessor of the Year" by the County of Assessors. Their human resources department was ranked #1 for middle sized counties.

Town of Grand Lake, Jim White: The town recently passed a 4.3% sales tax revenue bond for drainage, lighting, and beautification of the town. Grand Lake's introduction of micro and hydroelectric power at their hydro plant charging station has been a success. They are currently working on solar lighting for entryway.

Town of Walden, Sarah Wyatt: The town's general fund recently experienced a surplus. They received a grant to upgrade their sewer plant. Walden is also starting their recreation park restoration project.

SUMMARY BACKGROUND



Northwest Colorado Council of Governments (NWCCOG) is located in the northwest portion Colorado just west of the Front Range, and includes the counties of Eagle, Grand, Jackson, Pitkin and Summit. NWCCOG is the region designated by the State of Colorado as State Planning and Management Region 12. It is in the heart of the Rocky Mountains and is characterized by its mountainous terrain and very high overall altitude. The most recent population figure reported from the State Demography Office is 117,691. The region consists of 6,779 square miles, for an overall population density of 17.36 persons per square mile.

Region 12 is located in the northwest section of the State of Colorado. Most of the area is located among the high peaks of the Colorado Rockies. The region is bordered in the East by the Continental Divide, in the north by the State of Wyoming in Jackson County, to the west by Garfield County, and to the South by the Elk Mountain Range in Pitkin County. It is considered the "high country", as elevations range from a high point of 14,270 (Grays Peak in Summit County) to a low of 6,312 in the Town of Gypsum in Eagle County. The average elevation of the towns in Region 12 is 8,124 feet above sea level.

Re: EDD Bylaws and Board Composition

Required Action: Approval of amendment to EDD Bylaws and Board Roster

Background:

The EDA recently revised several regulations with respect to bodies that govern economic development districts. EDA's revised regulations, which took effect on January 20, 2015, promote two key pillars of EDA: innovation and regional collaboration. The final rule encourages coordination and the leveraging of other federal resources while providing greater flexibility to EDA stakeholders. Some key changes were made to the regulations governing the Comprehensive Economic Development Strategies (CEDS) process, EDA's Planning program and Economic Development Districts (EDDs). These changes include:

Eliminates the current membership thresholds for EDD policy boards, so:

- No longer required that EDD policy boards include at least a majority of its membership being elected officials or employees of a State, local or Indian tribal government appointed to represent the government.
- No longer required that EDD policy boards include at least one private sector Representative.
- No longer required that EDD policy boards include one or more representatives from Chambers
 of Commerce, institutions of post-secondary education, workforce development groups, or
 labor groups, all of which must aggregate a minimum of 35 percent of the District Organization's
 governing body.
- In lieu of the membership thresholds, EDA maintains the requirement that the governing bodies
 must demonstrate that they are broadly representative of the principal economic interests of
 the region and adds the requirement that governing bodies must demonstrate the capability to
 implement the relevant CEDS.
- District Organizations must meet at least twice a year, instead of annually.

The EDD Board of Directors reviewed the proposed bylaw amendments and proposed board roster attached to this memo at the December 8, 2016 board meeting. Minor changes to the language were incorporated. These changes reflect the new EDA regulations and provides the EDD with more flexibility in makeup of the board of directors such that we can keep innovation and regional collaboration at the center of our work.

Recommendation:

Staff recommends the EDD Board of Directors approve the amendments to the EDD bylaws and proposed Board Roster for 2017.

BYLAWS OF THE NORTHWEST COLORADO COUNCIL OF GOVERNMENTS ECONOMIC DEVELOPMENT DISTRICT

ARTICLE I Adoption and Effect

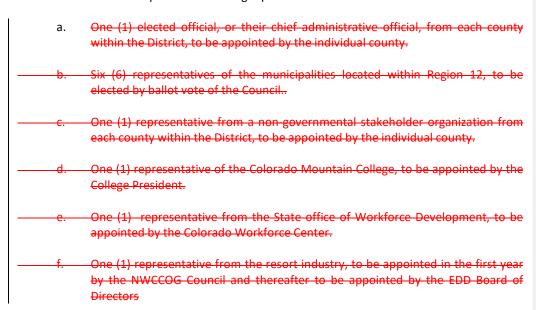
These Bylaws shall become effective upon the adoption thereof by a majority of the voting representatives of the Northwest Colorado Council of Governments Economic Development District (hereinafter, the "District" or "EDD Board") at any regular meeting, and shall not be construed to operate in contravention of any provision of the Articles of Association, Northwest Colorado Council of Governments/Economic Development District ("Articles of Association"). Any provision herein determined to be contrary to or in violation of the Articles of Association shall be null, void, and of no effect.

ARTICLE II Representation, and Voting

1. Representation

The EDD Board shall consist of members that broadly represent the principal economic interests of the region. no less than fifty-one percent (51%) governmental representatives and no less than thirty-five percent (35%) non-governmental representatives.

The EDD Board shall comprise the following representation:



- G. One (1) representative from the health care industry, to be appointed in the first year by the NWCCOG Council, and thereafter to be appointed by the EDD Board of Directors
- One (1) representative from each Member Jurisdiction located outside of Region 12, appointed by the jurisdiction.
- One representative from each of NWCCOG's Member County Governments (Eagle, Grand, Jackson, Pitkin, Summit).
- o At least one representative from a municipality in each of NWCCOG Member Counties.
- At least one representative from a municipality in one of NWCCOG's affiliated member
 municipalities outside Region 12 (i.e. Steamboat Springs, Carbondale, or Glenwood Springs).
- One Economic Development Organization (EDO) Representative from each of <u>NWCCOG's Member Counties (could be a Chamber of Commerce, Business</u> Association, Visitor's Bureau, DMO, etc.).
- One representative from Workforce.
- One representative from Education.
- o One representative from each of the region's key industries.

i. Each appointing authority may also appoint or elect one alternate for each representative it appoints or elects to the Board.

2. EDD Board Officers.

EDD Board officers shall be elected by majority vote of the representatives. Officers shall serve for a term of two (2) years from the date of their election.

- a. <u>Chairman</u>. The Chairman shall preside at all meetings of the EDD Board and shall be the chief officer of the EDD Board.
- b. <u>Vice Chairman</u>. The Vice Chairman shall exercise the functions of the Chairman in the Chairman's absence or incapacity.
- c. <u>Secretary-Treasurer</u>. The Secretary-Treasurer shall exercise the functions of the Vice Chairman in the absence or incapacity of the Vice Chairman and shall perform such other duties as may be consistent with the office of Secretary-Treasurer or as may be required by the Chairman.

3. <u>Term of Representation</u>

Formatted: English (U.S.)

Each representative shall serve a two year term unless sooner replaced by the appointing authority. Representatives shall serve on the EDD Board at the will of the appointing authority. All representatives serving on the original EDD Board shall serve from the EDD Board's inception until the second January following the EDD Board's creation.

4. Allocation of Voting Rights

Each representative shall be entitled to vote on any matter that requires a vote by the Board. Each representative shall have a total of one vote. Only the representatives of those appointing authorities whose dues payments are current are entitled to cast a vote at a meeting of the EDD Board.

5. **Quorum**

A quorum shall consist of no less than seven representatives or their alternates. To pass a budget or set dues, the majority of the representatives comprising the quorum shall be government representatives.

6. <u>Telephone Polling</u>

In order to achieve a quorum, the EDD Board may poll by telephone, not more than two representatives, with respect to a specific matter before the EDD Board on motion or resolution. Such telephone polling shall constitute the equivalent of a physical presence at the meeting of the representative(s) so polled, shall be carried out by the Chairman, and the results of the poll reported to the EDD Board by the Chairman. The minutes for the meeting shall reflect that a telephone poll was taken, the results thereof, and the representative(s) polled by telephone. Further, a memorandum of the telephone poll shall be approved and signed by the polled representative. If the representative(s) does not approve and sign the memorandum, the action upon which the vote, including the poll, was taken shall be null, void and of no effect.

7. Electronic Voting

With prior approval by the EDD Board, the representatives may vote via electronic means on subjects not related to the budget or the setting of dues.

ARTICLE III Annual Dues Assessment Policies

1. Dues Assessment and Payment

a. The EDD Board will receive a dues payment from the Council equal to 50% of the EDD's adopted budget minus other revenues received or budgeted to be received.

- b. The EDD Board shall adopt a voluntary dues structure that applies to private sector representation, to offset the costs of adding the private sector representatives to the EDD Board and to be applied toward matching the federal dollars.
- c. By August 31st, the EDD Board shall send notices stating the amount of the next calendar year's annual dues assessment. Confirmation of intention to pay the assessment is due to the EDD Board by October 31st. Dues assessments are due and payable on an annual basis by February 28th.

2. Required Withdrawal from EDD Board

In the event of non-payment of dues the EDD Board may by majority vote require that the non-paying entity withdraw its representation on the EDD Board.

ARTICLE IV Financial Management

1. Annual Budget

Each year between October 1 and October 15, the Chairman shall submit, by mail, to the EDD Board an estimate of the budget required for the operation of the EDD Board during the ensuing calendar year.

2. Funding Sources

The EDD Board is specifically empowered to contract or otherwise participate in and to accept grants, funds, gifts or services from any Federal, State or local government or its agencies or instrumentality thereof, and from private and civic sources, and to expend funds received therefrom, under provisions as may be required of and agreed to by the EDD Board, in connection with any program or purpose for which the EDD Board exists.

3. **Accounting**

The EDD Board shall arrange for a systematic and continuous record of its financial affairs and transactions and shall obtain an annual audit of its financial transactions and expenditures.

ARTICLE V Executive Staff

1. Hiring and Termination

The NWCCOG Executive Committee shall appoint professional Executive Staff who shall serve at the pleasure of the EDD Board, and may be hired and/ or terminated only by a vote of the

Council pursuant to Article II Section 3 of the Amended and Restated Bylaws of the Northwest Colorado Council of Governments.

2. **Duties**

The Executive Staff shall serve as the general administrators of the EDD Board and shall oversee the daily affairs in a manner that carries out the will of the EDD Board, including but not limited to the following authority:

- a. The Executive Staff shall implement personnel policies, and shall hire, supervise and terminate employment for the staff of the EDD Board.
- b. The Executive Staff shall have the authority to enter into contracts for services and materials on behalf of the EDD Board provided, however, that the EDD Board has previously approved budget items encompassing such services and materials, and the contracts implement items in the Work Program approved by the EDD Board. In no event may the Executive Staff enter into contracts in excess of \$20,000. The Executive Staff shall have the authority to dispose of, by sale or exchange, property and equipment of the EDD Board up to and including a value of \$1,000 per unit or market lot, as appropriate, without prior approval of the EDD Board. Upon approval of the EDD Board or Executive Committee, as appropriate, the Executive Staff may dispose of EDD Board property or equipment valued in excess of \$1,000.
- c. The Executive Staff shall have the authority to bind the EDD Board during the course of contract negotiations with present or future contractors with the EDD Board provided, however, that the specific contract under negotiation has previously been approved by the EDD Board. The Executive Staff shall have the authority to implement change orders and contract amendments consistent with the intent and purpose of previously approved contracts.

ARTICLE VI Amendment

These Bylaws may be amended by resolution of the EDD Board, approved by majority vote of the EDD Board.

ARTICLE VII Rules of Order

Except as otherwise provided in these Articles, Robert's Rules of Order shall prevail for the conduct of business of the EDD Board.

ARTICLE VIII

Meetings

The EDD Board shall hold meetings open to the public at least <u>once-twice</u> a year and shall also publish the date and agenda of such meetings sufficiently in advance to allow the public a reasonable time to prepare in order to participate effectively.

The EDD shall provide information sufficiently in advance of decisions to give the public adequate opportunity to review and react to proposals. The EDD shall communicate technical data and other material to the public so they may understand the impact of public programs, available options and alternative decisions.

The EDD shall make available to the public such audited statements, annual budgets and minutes of public meetings, as may be reasonably requested.

The EDD and its board of directors shall comply with all Federal and State financial assistance reporting requirements and the conflicts of interest provisions set forth in CFR § 302.17.

ARTICLE IX Committees

The EDD Board may establish advisory committees as may be necessary from time to time.

ARTICLE X Indemnification

The EDD Board shall indemnify, to the extent permitted by law, any person who is an officer, agent, fiduciary or employee of the EDD Board against any claim, liability or expense arising against or incurred by such person as a result of actions reasonably taken by him at the direction of the EDD Board. The EDD Board shall further have the authority to the full extent permitted by the law to indemnify its directors, officers, agents, fiduciaries and employees against any claim, liability or expense arising against or incurred by them in all other circumstances and to maintain insurance providing such indemnification.

NWCCOG proposes to continue employment of the Region XII Broadband Coordinator (RBC) through June 2018.

Since being hired in 2014, the Regional Broadband Coordinator (RBC) has been responsible for the development and coordination of broadband projects within Northwest Colorado and has been working with 7 participating counties (Eagle, Grand, Jackson, Pitkin, Rio Blanco, Routt, and Summit) to move forward county specific projects that are in alignment with the Regional Broadband Strategic Plan developed by NWCCOG in 2013.

The RBC has developed positive working relationships with local Internet Service Providers (ISPs) and has connected local governments with ISPs, creating increased communication and productive partnerships toward the common goal of improving broadband access in rural northwest Colorado. While most of the efforts are incremental, spanning years, the Regional Coordinator's efforts have already met with dramatic collaborative success, such as communications infrastructure (a tower) being constructed in Redcliff which will allow the town to make a case with internet and cell phone providers to bring service there, providing reliable internet service to town for the first time. Such success would be unlikely without having a Subject Matter Expert helping connect the dots.

Also included in this grant application is the provision for the RBC to assist the Department of Local Affairs (DOLA) in the development, review and monitoring of statewide broadband applications. The following is the proposed list of projects and goals of the NWCCOG Regional Broadband Program for July 2017 – June 2018, as recommended by the regional broadband steering committee and approved by the NWCCOG Council by vote on 1/26/17.

For 2017 (July – December):

- Continue to serve as a neutral broker/connector for providers, government, businesses and consumers.
- Continue to provide technical support to DOLA and participating local governments for projects and planning.
- Collect and aggregate information on demand and infrastructure to form building blocks for the Northwest
 Colorado Regional Middle-Mile Transport Network project (NWCRMM—connecting within the NWCCOG region).
 Strengthening the network through this effort will potentially invite greater competition among providers
 throughout the region, resulting in better service and lower business and residential prices.

7. Description: (Describe the problem, opportunity or challenge that resulted in the request.)

In 2013, with funding from DOLA's Energy and Mineral Assistance Funds (EIAF), NWCCOG completed an 8-county strategic plan for improving access to broadband. This document, available on the NWCCOG web site (www.nwccog.org), clearly identifies the problem of insufficient, and sometimes non-existent, broadband access, capacity, affordability, and reliability in northwest Colorado. The plan presented several recommendations to improve the broadband situation in the region.

In 2014, with an EIAF grant from DOLA, NWCCOG built upon that work by hiring a Regional Broadband Coordinator (RBC). The RBC is responsible for the development and coordination of broadband projects within Northwest Colorado and has been working with the participating counties to move forward county specific projects that are in alignment with the Regional Broadband Strategic Plan. The RBC has worked over the past several years to develop positive working relationships between local governments and ISPs, creating increased communication and productive partnerships toward the common goal of improving broadband access in rural northwest Colorado. During that time it has become very clear that most broadband projects take years to complete. NWCCOG understands that improving broadband in the region will require a long-term commitment, and sees this 1 year grant opportunity as invaluable for continuing work that has been bearing fruit and is gaining momentum.

On January 6th, 2017, the Regional Broadband Steering Committee, which includes a representative from each participating county, determined that although there are still county-specific projects to be completed for which the RBC will continue to play an integral role, the time has come for the RBC to begin tying these projects together in a larger, regional effort. The regional effort is defined as a regional middle-mile transport network loop (NWCRMM—connecting within the NWCCOG region) that encircles the eight-county region with multiple routes out to multiple POPs ("Meet Me" points), to aggregate demand to reduce the price per MB for all users, and provides multiple regional data centers for local government data back-up and storage services. Funding for the RBC position is needed to weave support for local efforts, into development, management and implementation of the Northwest Colorado Regional Middle-Mile Transport Network Project. The longer-term vision is that the Northwest Region's Regional Middle-Mile Transport Network (NWCRMM—connecting within the NWCCOG region) would be available to connect with the networks currently being built in Regions 9, 10 & 11 creating a robust network for Western Colorado. This is herein noted as RMMTN, the connection effort which also includes Regions 9, 10 & 11.

Funding is needed now to continue the efforts toward regional broadband improvement through the employment of the Regional Broadband Coordinator without disruption that could cause projects to be delayed and regional momentum to be lost. The RBC serves as a program manager for projects that span changes in local government & agency leadership. One reason for the success of NWCCOG broadband projects is the unique capabilities, skills, knowledge and experience of the current coordinator. This has also allowed NWCCOG to develop partnerships and deploy projects with both existing and emerging internet providers. The RBC is also a contributing partner with the State of Colorado OIT on both broadband and FIRSTNET Colorado programs as well as providing technical & programmatic support to the State of Coloardo DOLA Broadband Grant Program. The support includes sharing lessons learned "in the field" as well as providing technical expertise to local governments across the state and dovetailing broadband and telecommunications infrastructure into other DOLA EIAF Grant funded projects.

b. How does the implementation of this project address the need?

The continued employment of the Regional Broadband Coordinator is critical to the project. Without the dedicated time of this individual with substantial technical knowledge and industry experience, local governments will be less likely to make significant progress on either their local projects, and there would be no one focused on establishment of the larger regional network.

c. Does this project, as identified in this application, <u>completely</u> address the stated need? If not, please describe additional work or phases and the estimated time frame. Do you anticipate requesting Energy and Mineral Impact Assistance funds for future phases?

Improving broadband on the Western Slope is a long-term effort and will need to continue beyond this grant.

Our region covers much of the central part of Colorado that was greatly, historically impacted by mining.

NWCCOG serves 27 local governments including the municipal and county governments of Region 12 that are impacted, both directly and indirectly. NWCCOG member jurisdictions include:

- Eagle County and the Towns of Basalt, Eagle, Gypsum, Minturn, Red Cliff and Vail
- Grand County and the Towns of Fraser, Granby, Grand Lake, Hot Sulphur Springs, Kremmling and Winter Park
- Jackson County and the Town of Walden
- Pitkin County and the City of Aspen
- Summit County and the Towns of Dillon, Frisco, Montezuma and Silverthorne
- Although not in Region XII, the City of Glenwood Springs, the City of Steamboat Springs and the Town of Carbondale have also joined NWCCOG.

Eagle County- As a result of nearly 100 years of mining activity, the Eagle River has been polluted by heavy metals, sediments and other contaminants. The Eagle Mine was officially declared a Superfund site. Additionally, the rail line running next to the river has caused significant damage. The Centrex American Gypsum plant and mine are located in Eagle County. This plant and mine employs 120 people and operates 24 hours/day.

Grand County – The Henderson Mill is located on the west side of the Continental Divide, fifteen miles from the mine in Grand County. The Henderson Mine is located in Clear Creek County on the east side of the Continental Divide, fifty miles west of Denver, Colorado. In operation since 1976, Henderson has produced more than 160 million tons of ore and 770 million pounds of molybdenum during the past 27 years.

Jackson County – Coal bed and natural gas production for 2012 to date is 143,506 MCF's; oil production is 184,778 BBL's. The number of drilling permits in Jackson County to date for 2012 is 5. Jackson County currently has 187 active oil and gas wells. (*Source: Colorado Oil and Gas Conservation Commission*).

Pitkin County - Historically Pitkin County was heavily influenced by silver mining. Clean up and remediation activities associated with the mining past continues today. There are 753 abandoned mines in Pitkin County.

Summit County – Construction restarted in 2010 on the Freeport-McMoRan's Climax Molybdenum mine. The mine is located 13 miles northeast of Leadville at the top of Fremont Pass (located in both Summit and Lake Counties). A great deal of its workforce comes from Summit County. Molybdenum production is expected to ramp up to a rate of 20 million pounds per year during 2013 and, depending on market conditions, may be increased to 30 million pounds per year. Climax currently employs 300 people. Should the production rate increase to 30 million pounds per year, employment could increase to approximately 400. Also, several county residents commute to the Henderson Mill and Mine facilities in Clear Creek and Grand counties. There are 600 abandoned mines in Summit County. Clean up and remediation activities associated with the mining past continues today. Fluid and gas pipelines contribute a total value of \$21.7 million in assessed valuation.

RE: 2017 Legislative Session and monitoring transportation legislation for NWCCOG Council.

The NWCCOG Council requested that QQ staff, Torie Jarvis, monitor and provide updates on transportation legislation during the 2017 State Legislative Session. Torie plans to provide this service to NWCCOG while she is lobbying and providing legislative updates on behalf of QQ.

The 2017 Legislative Session started on Wednesday, January 11th and will end on May 10th. A handful of transportation-related bills were introduced in the first week of the Session, and Torie is currently preparing the first update for the Council. An example legislative update for QQ is below, for the Council's review and input if there is another approach that is preferable. In general, updates will include a summary of newly introduced legislation and updates on where other bills are in the legislative process.

The Colorado General Assembly's makeup is divided between parties in 2017. Republicans hold a slim one-seat Republican majority in the Senate, and the Democrats hold a nine-seat majority in the House (gaining several seats from incumbent Republicans).

The NWCCOG region is well-represented in leadership in both houses this year, particularly regarding transportation legislation. Grand County Representative KC Becker will be the incoming majority leader in the House. Eagle and Routt County Representative Diane Mitsch Bush is the Chair of the Transportation and Energy Committee. Grand, Summit, and Routt County Senator Randy Baumgardner is the Chair of the Senate Transportation Committee.

Sample legislative update:

HB 16-1255. Methods to manage Forests to Improve Water Supply Conditions. Sponsored by Rep. Coram & Vigil.

- Part 1 directs the State Forest Service to work with the USFS on a series of pilot projects
 to "implement forest management treatments that improve forest health and resilience
 and supply forest products to Colorado businesses." The State Forest Service currently
 receives one million dollars annually for projects with the USFS; this bill directs that
 \$200,000 would be spent specifically on these pilot projects.
- Part 2 commissions a study with the State Forest Service and CWCB to study forest management in protecting and managing Colorado's water resources, including

- analyzing the costs if proper forest management does not occur and a forested area burns and benefits of completing forest management treatments.
- Part 3 creates a 24-person forest health advisory council to advise the State Forest Service.

HB 16-1256. South Platte Water Storage Study. Sponsored by Rep. Brown; Sen. Sonnenberg.

 Directs the CWCB to study the amount of water passing into Nebraska in excess of the South Platte River Compact and possible locations for water supply projects along the main stem and tributaries of the South Platte. The \$250,000 study will be funded from the severance tax fund. Representative Brown stated at Water Congress that this source of funding is open for discussion, and he is meeting with

<u>SB 16-097</u>. Severance Tax Revenue for Local Governments. Sponsored by Sens. Scott, Baumgardner, Cooke, and Rep. Coram.

- Prevents transfers to the general fund from severance funds, which include:
 - o Higher education federal mineral lease revenues fund
 - Higher education maintenance and reserve fund
 - Local government permanent fund
 - Local government mineral impact fund
 - o Local government severance tax fund
- Limits the governor and the joint budget committee's ability to use money in the severance fund for any purpose "not authorized by law" or that does not benefit political subdivisions "socially or economically impacted by" mineral development.
- Section 5 changes the percentage of direct distributions of severance tax funds from 30% to 60%, and the proportion for granting is reduced from 70% to 40%. Grants may only be given to a political subdivision that received more that \$200,00 from its direct distribution in the prior fiscal year.
- We have heard that the bill is expected to change substantially due to stakeholder concerns.

Background:

The WorkWell Collaborative is a partnership between Eagle County Public Health and Environment, Northwest Colorado Council of Governments, and Health Links Colorado made possible by a grant from the Colorado Department of Public Health and Environment's Cancer, Cardiovascular, and Pulmonary Disease program. Award amount and term: \$225,000 annually for three years: July 1, 2015 through June 30, 2018. The goal of the WorkWell Collaborative is to create a coordinated system across NWCCOG's region to support employers to develop and sustain workplace wellness programs through the implementation of Health Links Colorado. This will increase the number of employers offering comprehensive and evidence-based workplace wellness programs.

NWCCOG became involved in this initiative because of how worksite wellness relates to economic development, and because of our role as convener on issues which affect our regional economy. Worksite Wellness programs strive to improve employee health, improve employee morale, improve productivity, contain costs, decrease absenteeism, and increase employee retention, all of which can lead to a healthier bottom line for our region's businesses. A healthy workforce leads to a healthy economy.

Highlights

Since the beginning of the grant (July 1, 205):

- 74 employers across NWCCOG's region have received kick-start funding or certification through Health Links.
- Total number of businesses enrolled in Health Links to date: Eagle County 27; Grand County 6; Jackson County 4; Pitkin County 19; Summit County 18.
- Over 10,000 employees are being influenced by organizations committing to worksite wellness through Health Links across the five-County region. (Approx. 8,000 full-time, 1,500 part-time, 350 contract).
- The WorkWell Collaborative recently initiated an Accelerator Program, which allowed kick-start or certified employers to apply for up to \$1,000 to fund capital improvements

- at their workplace that support their worksite wellness goals and initiatives. Fourteen employers received reimbursement for items purchased. Examples include insulated work gloves for RA Nelson Construction crews, lactation accommodations for nursing mothers at Garfield County Government, and several employers got standing desks for employees. Another round of Accelerator Program is being planned for this spring.
- The Lead Advisor in Summit, Diana Reznikoff, has been working closely with the Summit Chamber to support the development of their first annual awards, which will include a Workplace Wellness Champion category. The Summit Chamber Excellent Awards event is Thursday, Jan 26 5-8:30pm at the Silverthorne Pavilion. Diana/HL will present the Workplace Wellness Champion award.
- The Lead Advisor in Pitkin County, Amanda Wagner, has been working closely with Garfield County Public Health (they have a similar grant focused on worksite wellness) to put together the Mountain Communities Health and Wellness Symposium for Small Businesses, which will be held from 8am-12pm Friday March 31st at the Glenwood Springs Recreation Center. The symposium will be geared towards small businesses seeking more information on workplace wellness programs that are affordable, easy to implement, and will create a return on their investment. The morning's program will include an excellent keynote speaker, a course on simple desk or chair movements to reduce injury, and a panel of local business partners who have been running successful wellness programs.
- The Core WWC team is working with lead advisors to develop an outreach and marketing plan for each County.

The WorkWell Collaborative grant ends June 30, 2018, however we would like to continue this work in the region. NWCCOG may consider having a discussion on playing a role in carrying this work forward.

Katie Haas, Healthy Communities Supervisor for Eagle County Public Health, will be giving a presentation on the Work Well Collaborative at the January 26, 2017 EDD Board Meeting.



PROGRAM UPDATES

The following are the events of note that have occurred since the December 8, 2016 NWCCOG meeting.

<u>Administration/Regional Business</u> – Jon Stavney, Executive Director

Since the Council meeting in December, I've performed 9 very important employee reviews, one with each of our directors which were each wonderfully productive discussions about their aspirations for COG, their teams and for future direction of each program. I've finalized wage changes for all employees, made my first grant reimbursement submittal and by the end of January will have submitted my first grant and performed closeout on another. Dues invoices were sent out last week, and I added a cover letter. A great deal of my time has been spent on making key (if not systematic) connections with people across the region, and editing documents like the GAP executive summary, writing press releases, working with Judi on newsletters. Communications is definitely a focus of mine. I hope you are beginning to feel "the word is getting out" about what we do. I've added a "from the Director" segment to our Newsletter and am delegating the next few months to Torie, Erin, Rachel, and Doug in an effort to personalize that document. I am focusing a great deal on organizational culture, and on strategizing membership outreach—including a number of first stage meetings I've had with each of our three outlier jurisdictions.

I've dived deeper into Nate's Broadband network network (not a typo), Kims All-Hazards world and Amanda's "Being Mortal" through meeting with each. One item I am most excited about is the rollout of Mass Economics outreach in Grand County under the EDA grant. Rachel and I were on the selection committee that selected ME for this economic resiliency implementation effort and I'm looking forward to being present as they begin gathering community input.

I still have considerable work to do this winter in reviewing and rewriting our Policies & Procedures as well as our Employee Handbook, and would welcome suggestions for who I might tap in your organization for input on this effort. I will be blending that internal focus with my increasingly busy meeting schedule while beginning to plug in more outreach meetings with member jurisdictions to listen and learn of their individual needs. I am strategizing on how to gather input from each of your jurisdictions about needs that COG could address, and in gathering information about innovation and good governance to share with each of you. No shortage of good work to do at NWCCOG, and I am enjoying myself—even, strangely, the snowy commute which gives me a lot of thought-time about the organization and challenges I hear about in each of your communities. Don't be surprised if you get a call from me on the road.

Alpine Area Agency on Aging (AAAA) – Erin Fisher, Director Provider & SUA Evaluations: The AlpineAAA has begun planning for the SFY 15-16 Provider Onsite Evaluations. These annual evaluations will take place in February and March. We have also received notice that the annual Statue Unit on Aging evaluation will be a desk evaluation and will take place April 24-26th.

Being Mortal Discussions: The first Being Mortal discussion took place on January 11th at the Summit County Community & Senior Center. The turnout was stunning; we received over 100 RSVPs for the event. We believe that the other Being Mortal events taking off throughout January and February in the region will be equally as well-attended.

<u>State Health Insurance Assistance Program (SHIP)/Senior Medicare Patrol (SMP)</u> –T.J. Dufresne, Health Insurance Assistance Coordinator

The 2017 Medicare Annual Open Enrollment Period (OEP) was a success in the five county region. Due to outreach efforts over the year, the OEP demand was high. We received daily phone calls and email requests for assistance. There were fewer enrollment system issues than during the 2016 Open Enrollment Period. Most of the issues were due to high server access demand and access was successful after a few attempts to get into enrollment applications. Below is a summary of our Medicare Assistance Contacts.

Medicare Beneficiary Contacts November – December 2016

We had five active Volunteer Medicare Counselors in addition to the Program Coordinator meeting with Medicare beneficiaries throughout the OEP. Due to the time of year, many volunteers were traveling different weeks during our OEP. We will work to increase the number of Volunteer SHIP Medicare Counselors to include recruitment of Open Enrollment Period only volunteers to help meet capacity needs for next year.

We are still without access to on-boarding new volunteers at this time due to the change-over from SHIP being under the Centers for Medicare and Medicaid Services (CMS) to the Department of Community Living Services (CLS) where other aging services and agencies are directed from. We have also found more volunteers to assist with programs operations to include data entry assistance, newsletter support, program promotion (distribution of flyers and other materials), organizations hosting Medicare Basics events, among other facets of the program.

Our community partners have been integral in the referral process. We saw an uptick in referrals steadily through the Open Enrollment Period. Friends and family referrals have also increased. We will work to strengthen and expand our partnerships. We will also add focus to targeting low-income Medicare beneficiaries as well and our

Economic Development District (EDD) - Rachel Lunney, Director

Comprehensive Economic Development Strategy: The CEDS 30-day public comment period started December 15, 2016 and closes on January 15, 2017. The CEDS is up for final approval by the EDD Board of Directors at the January 26, 2017 board meeting at Colorado Mountain College in Edwards.

Future of Mountain Towns through Entrepreneurship and Innovation: We will be exploring strategies for creating an entrepreneurial ecosystem in our region in 2017 including:

- OEDIT Blueprint 2.0 Technical Assistance Program NWCCOG has been awarded an OEDIT Blueprint 2.0 technical assistance grant for "Incubator/Accelerator Best Practices". The award is not cash, only technical assistance through OEDIT. We will be sending a regional team of stakeholders to attend the Mountain Ventures Summit in Telluride Feb. 2-4. At this summit we will visit the Telluride Venture Accelerator, and learn about the Southwest Innovation Corridor. We will also have an opportunity to learn about strategies and programs other mountain towns are pursuing to further entrepreneurship and innovation.
- Rachel has been invited to participate in a group of stakeholders in Summit County to work with Elevate CoSpace on some of their initiatives 2017 including: creating a pathway for locals to transition from seasonal jobs to careers; development of a new business "bootcamp" in 2017 to explore an incubator or accelerator with NWCOG and others; creation of a mentor program for local businesses and nonprofits; continuing to host events and activities like Startup Weekend events, entrepreneurship programs, etc.; explore working with CMC on workforce training (like the Full Stack web development program and others).

WorkWell Collaborative: The team has developed an outreach and marketing plan for the remainder of the grant (Jan. 1 – 2017 – June 30, 2018). This includes a radio ad campaign, print ads in county newspapers, training events, and another accelerator program whereby certified healthy businesses can apply for funds for capital expenditures for worksite wellness improvements to their business. We have been working with Jessica Valand, new regional director for the Rural Resort and Northwest Region's Workforce Development Boards, and Chris Romer, Chair of the RRR board, on having "Worksite Wellness" as a standing agenda item on each quarterly RRR WDB meeting. This will allow discussion and feedback from the board, which includes key industry representatives, on how to best reach businesses in these key industries on worksite wellness issues, and which areas of interest we need to focus on. Katie Haas, Eagle County Public Health Healthy Communities Coordinator, and Rachel Lunney will give an update on the WorkWell Collaborative at the January 26, 2017 EDD Board Meeting.

EDA – Economic Adjustment Assistance grant for Grand/Clear Creek Counties: The grant in the amount of \$100,000 (matched by \$100,000 from Climax Molybdenum) has been awarded. The grant funds will be used to hire a contractor to conduct a study of the economic impacts of the imminent closure of the Henderson Mill and Mine in those 2 counties. Mass Economics, a consulting firm out of Boston, Massachusetts, has been selected to complete the project. The contract has been finalized, and work will commence after January 15th.

Elevator Inspection Program (EIP) – Steve Allen, Director

The Elevator Inspection Program has kept current with the Annual Inspections while increasing the number of 5 Year witnessing tests. We are also current on new construction and modernizations. We have a record number of 5 year witnessing tests completed for 2016. The Building Officials for our jurisdiction are working with us to meet our goals. 2017 has started out at a greater pace than any previous year. The E.I.P. program has contracted with a Q.E.I. certified, State licensed Inspector to increase productivity and they have already started completing inspections.

Energy Management (Weatherization)- Nate Speerstra, Weatherization Program Specialist

The crews in the weatherization department continue to excel towards our goal of 96 completed units for the year. By the end of December we are on track in terms of our budget and ahead of schedule with regards to production. The Colorado Energy Office has conducted their first of two Quality Assurance inspections on a random selection of our

completed units. 6 homes were inspected over a 3 day period and the report had no findings or concerns with the work that our crews had done.

In the Crisis Intervention Program, the "no-heat" calls continue to come in. We have 22 jobs so far. 16 of them have been successfully resolved with temporary heat provided to the other 6 until parts come in for the repair. The CARE program continues to grow with the addition of CORE in Pitkin County reaching out to us for possible sub-contracting work.

Northwest All Hazards Emergency Management Region (NWAHEMR) – Kim Cancelosi, Coordinator
The NWAHEMR elected new board members for a two-year term at the Regional meeting on January 18, 2017. Over the last two years, the current board has accomplished a great deal and their dedication is greatly appreciated. A special thanks goes out to Joel Cochran, Chris Bornholdt, and Nowell Curran for sitting as the Chairperson and vice chairs.

Grand County has hired Christian Hornbaker as their new Emergency Manager. Grant applications under the Homeland Security Grant Program are being accepted until 5:00 p.m. on February 1, 2017.

Northwest Loan Fund (NLF) – Anita Cameron, Director

Two new loans were closed and funded in December. A new loan application has been received for analysis. Anita will take two weeks of vacation in January. Whitney Smith has been contracted to work part-time for the NLF.

Regional Transportation Coordinating Council (RTCC) – Susan Juergensmeier, Mobility Manager
The Mountain Ride Transportation Resource Center has now been in operation for 2 ½ years. In that time, over 14,000 one-way trips and associated services have been coordinated through the Call Center. All seven counties in the RTCC service area have had residents use our service.

On January 12, the NWCCOG received the signed contracts from the Colorado Department of Transportation (CDOT) for the extension of the Veterans Transportation and Community Living Initiative (VTCLI) grant and the FASTER match grant. They have been extended through December 2017. There is approximately \$102,000 remaining on the VTCLI-1 award and \$2,500 on the FASTER award. This will help fund the operation of the Mountain Ride Transportation Resource Call Center through 2017.

On January 13, an application for funding was submitted to the Anschutz Family Foundation for \$10,000 in operating funds for the Call Center. Jon and Susan are meeting with a representative the week of this council meeting. Award announcements will be in May.

The next Regional Transportation Coordinating Council meeting will be held on February 1, 2017.

Water Quality and Quantity Committee (QQ) – Lane Wyatt and Torie Jarvis, Co-Directors

Watershed Services will represent NWCCOG as a NEPA cooperating agency for the Bureau of Reclamation's Grand Lake Clarity Project. This project is an assessment of alternatives to modify the Colorado Big Thompson project operations and/or structures in order to improve water quality in Grand Lake. The NEPA project is supposed to start in January 2017.

QQ's next board meeting is scheduled for Thursday, March 2nd in Frisco.

QQ is participating in the upcoming Gunnison Basin Water Quality Standards Rulemaking on behalf of Crested Butte, Gunnison County, and the Upper Gunnison Water Conservancy District. QQ is participating in this rule making to track the way the Division and Commission handle temperature issues, specifically changes to the shoulder season standards, as we focused heavily on these issues during this year's Basic Standards rule making.

Funding for boat inspections that prevent the introduction of aquatic nuisance species like quagga and zebra mussels has been steadily declining in the past couple of years. To make matters significantly worse, a recent Colorado Supreme

Court case considerably reduced available severance tax spending, meaning that funding for the boat inspection program for 2017 and onwards is completely gone. Due to the successful boat inspection program to date, Colorado is one of few Western states without an infestation in any of its lakes and reservoirs. QQ has been a leader in advocating for increased funding from state and federal agencies and will continue to work on this importation issue.

- **Update:** Contributions from other agencies and governments remain slim, so currently there is no state or federal funding available for boat inspections in the NWCCOG region; local governments have pitched in to maintain a partial boat inspection program in Ruedi Reservoir.

QQ members recently requested the contract staff team develop a memorandum explaining how the Water Quality Control Commission designates stream segments and water bodies as Outstanding Waters and how such a designation affects its members. QQ contract staff sent that memo to members at the end of November.

QQ continues to work on cooperative adaptive management on the Upper Colorado River system, including the Learning By Doing Cooperative Effort, implementing the CRCA, the Grand Lake Clarity Adaptive Management efforts, and the Upper Colorado Wild and Scenic Stakeholder Group.

QQ is looking forward to working with NWCCOG to commission an update of it's 2011 study, Water & Its Relationship to the Economies of the Headwaters Counties, along with an update of QQ's Model Water Quality Standards & Definitions from the 1990s during 2017. Thank you to NWCCOG for your support!

<u>Broadband Program</u> – Nate Walowitz, Regional Broadband Coordinator Regional Impact Projects

1. NWCCOG Regional Broadband Network

Timeframe: CY 2016-2020

Priority: A

- Nate is conducting meetings throughout NWCCOG to share the objectives of the Regional Broadband Network project to local governments and partners.
- New NWCCOG Executive Director, Jon Stavney and Nate Walowitz will start on regional listening tour in the first quarter of 2017. We will be meeting with counties and towns across NW Colorado to educate public officials on the 2017-2020 regional plans.
- DOLA Grant application for 2017-2020 has been put on hold till February.

2. Broadband Legislation and State Broadband Policy

Timeframe: CY 2016/2017

Priority: A

- Rumors are that there will be broadband legislation introduced by industry. There is more certainty around the cable industry introducing at least one bill. We will be working with the Steering Committee, Torey Jarvis, CCI and CML to help craft language as needed.

3. NWCCOG Service Provider Relationships

Timeframe: CY 2016/2017

Priority: A

- CenturyLink continues to not release county and statewide maps for CAF II funding locations.
- CenturyLink continues to ask for partnerships to leverage state funding for their projects. They have appealed the State of Colorado Broadband Deployment Board awards. The Broadband Deployment Board meeting in mid-December did not fully resolve the outstanding issues.
- ForeThought submitted a proposal to the Colorado Broadband Deployment Board for the radio and site infrastructure for middle and last mile for Red Cliff at the Ski Cooper Site. Buildout is scheduled for Spring/Summer 2017. ForeThought was awarded the grant.
- Mammoth Networks is working in Grand County to enable fiber broadband services to a number of businesses in Tabernash. Comcast quoted \$100,000 build project required to enable these businesses that are less than a quarter mile from the fiber node.
- ForeThought has purchased San Isabel Telecom and will be working to improve broadband and telecommunications services in their service area.
- Comcast has been silent in the past quarter with no updates from them nor any requests for partnership.

- Nate sent notices of the Summit County RFIs to all regional service providers. I have heard from a number of parties that they intend to respond to one or both of the RFIs.

4. DOLA Broadband Grants

Timeframe: CY 2016/2017 Priority: A

- Fraser and Winter Park broadband sub-plan for their towns continues. Vantage Point is working as their consultant and will be producing a final report in January 2017.
- CTC completed the strategic plan for Summit County and has received a DOLA matching administrative grant. Final report is in draft form and RFIs are currently posted.
- Pitkin County has been awarded a DOLA grant for buildout of three mountaintop microwave system and reconstruction/enhancement of existing county owned tower sites for broadband and DTRS radio sites.
- NWCCOG Regional Broadband Grant application was put on hold by DOLA till February.
- Routt County BOCC approved funding for July 1, 2017 June 30, 2018.

5. State of Colorado OIT Broadband Mapping Project

Timeframe: CY 2016/2017 Priority: A

- State OIT is working on a number of projects including e-Rate, mapping and broadband speedtest/surveys. Brian Shepherd provides expertise and comments on DOLA grant applications.
- Nate has been working with Megan Chadwick to produce regional broadband statistics for the CEDS.

6. Grant Funding - USDA, FCC Broadband, FCC CAF, DOLA, Broadband Deployment Board

Timeframe: CY 2016/2017 Priority: A

- CenturyLink has accepted the CAF II statewide funding and in buildout mode. However, they have not disclosed details of where buildout in Routt and Grand counties has/is occurring.
- CenturyLink locations for CAF I and CAF II funding has been included in the CEDS data.
- Colorado Telehealth Network (CTN) program funds medical and mental health care provider broadband grant funding from USAC.
- The Broadband Deployment Board has approved projects for funding. CenturyLink has appealed the award process. All awards on hold.
- Forethought has been approved by the Broadband Deployment Board for funding of the Ski Cooper and Mosquito Pass broadband sites in cooperation with Red Cliff, Ski Cooper, and Park County.

7. Create a new Website with Economic Development that includes broadband data for CEDS.

Timeframe: Q2 - Q4 2016 Priority: B

- New NWCCOG economic development website is available. Broadband and ED information will be published to the site as the CEDs December deadline approaches.
- Site has been populated with data and will be updated as needed in the future.
- Cedar Networks, CenturyLink, ForThought/Brainstorm, Mammoth Networks and Sundial Communications have provided information for the CEDS. Other service providers including Comcast, Slopeside Internet, and Zirkel Wireless have not provided information for this Region 12 document.

8. FirstNet Colorado

Timeframe: CY 2016/2017 Priority: B

- Lawsuits have been filed in federal court again FirstNet and ATT by Rivada Networks. It appears that ATT was deemed the only eligible bidder for the FirstNet carrier partner for FirstNet however, there has been no formal announcement by FirstNet selecting ATT.
- To maintain fiscal due diligence, local governments need to start planning and budgeting for use of site
 infrastructure, costs, long-term public safety communications system investment, potential IT impacts, and
 long term changes in communication center policies, procedures, and first responder protocols and SOGs.
- FirstNet Colorado continues to evaluate options and network coverage needs to ensure that the FirstNet national proposal responses and FirstNet's design meets the needs around the state.
- FirstNet Colorado is providing training and information seminars around the state.
- FirstNet Colorado has released an RFI to the state managed RAN network, should Colorado choose to manage their own RAN and/or Opt-Out and build a state funded, not federally funded public safety broadband network.

9. Work with Estes Park and Grand County on Adams Tunnel Fiber Project

Timeframe: CY 2016/2017 Priority: D

- Adams Tunnel Fiber Project will be built in Fall/Winter 2016/2017.
- CenturyLink has interest in using this connection to deliver redundant path bandwidth to/from Estes Park and Grand Lake.
- Nate Walowitz spoke with Ken Fellman about commercial use of existing utility and WAPA fiber on June 2.
 He believes that there is some progress one the federal side but there is still no definitive policy for all federal agencies or quasi-public agencies like WAPA on fiber use for commercial broadband applications.

10. Broadband pricing in CenturyTel of Eagle markets

Timeframe: CY 2016 Priority: D

- While this issue is still exists, Eagle County has partnered with Mammoth Networks to provide a 10 Gbps alternate path at very competitive pricing. This broadband network path is available at the Eagle County Government Center in Gypsum.
- Jackson and Routt Counties still have broadband pricing challenges.
- Walden is now out of broadband capacity at their CO despite there being available fibers. CenturyLink will not invest funds improving network capacity to support the market. No CAF II funding is currently targeted for Walden or Jackson County.

11. Shared Data Repository for Cable Franchise Agreements

Timeframe: CY 2016/2017 Priority: D

- NWCCOG solicited and posted Cable Franchise Agreements from local jurisdictions on the NWCCOG Google
 Drive. This was shared with Local/County government officials and the NWCCOG Broadband Steering
 Committee. This shared folder will be updated as new agreements are received.
- These files have started to be referenced by Pitkin County.
- If you have any updates, please forward them for posting to the repository.

12. Statewide economic development GIS data project

Timeframe: CLOSED Priority: D

- Providing COG perspective on data and mapping requirements for statewide GIS integration project. This
 project is attempting to create a single statewide program that can be leveraged by multiple agencies and
 COGs.
- Updated SIO scoring and Top 4 initiatives selected to begin project implementation.
- Data project with provide mapping of both geocoded and data and non-geocoded data.
- NWCCOG input is no longer needed.

13. Ensure Steamboat Springs and Craig fiber connections have carrier-based dynamic routing and redundancy

Timeframe: CLOSED Priority: A

- This issue was reopened based on the July CenturyLink outage.
- CenturyLink updated Routt, County, Grand County and Kremmling on May 10th with the status of these network upgrades/updates.
- Path redundancy for voice and 911 voice operations are completed. No data circuits are included in this network update.

14. NWCCOG Internal Network and Hosted VoIP Phone System

Timeframe: CLOSED Priority: A

- NWCCOG VoIP hosted phone service from Fluent Stream is fully operational.
- The only component remaining is the need for additional training on their reporting package.

County/Local Government Projects

1. Eagle County

Timeframe: CY 2016 Priority: A

- Mammoth has resolved technical issues with their 10 Gbps wave circuit. Eagle County and San Isabel Telecom are connected and operational.
- Some western Eagle County residents will benefit from the Pitkin County tower and microwave project.
- Town of Gypsum is interested in engaging in conversations with providers about deploying broadband in the town. They will trench to the DMARC for services.

2. Grand County

Timeframe: CY 2016 Priority: A

- Grand County has selected a new IT Director. He starts in January.
- CenturyLink is installing fiber along U.S. 40 in Fraser in support of CAF 2 deployment.
- CenturyLink has proposed the county waiving all Right of Way fees for the CAF II construction project. CenturyLink says that they will roll the savings into additional resource deployments. County BOCC will need to evaluate and either approve or reject this CenturyLink proposal.
- Adams Tunnel project will directly benefit Grand County government, residents, businesses and ISPs. NWCCOG Region
 will also benefit if CenturyLink supports diverse, redundant routing using this link through Kremmling and potentially
 into Clear Creek County and I-70. Nate will be working with Estes Park to determine how best to leverage this for our
 mutual benefit.
- CDOT has an interest in developing fiber along the U.S. 40 corridor from Empire through Kremmling. Investigating with Comcast to learn how this project could be of mutual benefit and potential cost sharing.
- Mountain Parks Electric has received a final report from their consultant on FTTH. Nate attended the briefing and their board is considering the business case presented. They will need to most heavily populated areas of the Grand County to participate to make the business case work across the entire multicounty service area.

3. Jackson County

Timeframe: CY 2016 Priority: A

- Welcome to new County Commissioner Danny Manville. He will be representing Jackson County on the Broadband Steering Committee.
- The CenturyLink Central Office is out of broadband bandwidth to Walden. This means they cannot add any new internet customers.
- Mountain Parks Electric has contracted with a consultant to investigate fiber to the home and broadband support.
- NWCCOG created a draft of an RFP for County-wide broadband engineering services. The RFP is based on the successful Pitkin County RFP. Jim Murphy needs cooperation from his fellow commissioners and County Manager to complete this effort.

4. Kremmling

Timeframe: CY 2016 Priority: A

- Comcast continues to work to run fiber to Kremmling from Hot Sulphur Springs, turning over right of way perfection to the retail unit of the company. Project is stalled once again.
- Mountain Parks Electric has contracted with a consultant to investigate fiber to the home and broadband support. This could provide the town with the alternate provider and path they need to receive more affordable broadband at Front Range speeds to every home.

5. Pitkin County

Timeframe: CY 2016 Priority: A

- The County will create a multi-use fiber/wireless broadband loop connecting all their mountaintop sites, local government buildings, businesses and residents for public broadband deployment, public safety communications and County IT network redundancy.
- The DOLA broadband grant application has been approved for a Microwave and Tower project to support public safety and broadband throughout Pitkin, Southern Garfield, Western Eagle and Northern Gunnison Counties.
- Pitkin County is also working on two additional public safety projects; building out and moving their public safety radio communications from VHF to the State DTRS system.

8. Rio Blanco County

Timeframe: CY 2016 Priority: A

- Rio Blanco County is having a high profile PR event on January 3rd to promote their network and accomplishments.
- FTTx Project
 - 25 miles of conduit in each town done!
 - 25 miles of fiber jetting in each town done!
 - 25 miles of splicing done in Rangely and 25 miles in Meeker to be completed circa January 2017.
 - 40 gbps fiber link between the two towns, 65 miles apart done!
 - New Data Center in Rangely done!
 - New Data Center in Meeker circa March 2017
 Drop runs to homes/businesses started.
 - Over 130 customers lit, over 600 current pending requests, and we are running about a 67% initial take rate on the portion of the network that can be lit at this time.
- FTTT Project

- 8 Primary Towers engineered, constructed, FCC licensed pathways, two fiber fed done!
- Last-mile wireless selected and purchased will be hung and lit 2nd Quarter of 2017.
- Secondary tower project, pending budget approval commences in 2017.

9. Routt County

Timeframe: Q3/Q4 2015 Priority: A

- Routt County BOCC has approved funding from July 1, 2017 June 30, 2018.
- DOLA awarded a grant for fiber extension to connect County Justice Center and Yampa Valley Electric Association to the NCB CNI.
- Routt County is working with fiber contractor to install network conduit and fiber.

10. Summit County

Timeframe: CY 2016 Priority: A

- CTC is working to finalize the county broadband sub-plan that includes broadband and cellular planning for the county. This includes strategy in the Lower Blue, the Lower Blue cellular tower site, the Landfill tower site, communications in Summit Cove, the Town of Heeney and the Town of Montezuma.
- Two RFIs have been posted for bid to assist the county in gauging interest and support in improving broadband and cellular service throughout the county.
- Summit County and Frisco businesses are interesting in obtaining business class broadband at lower prices. NWCCOG is working with them and the providers to determine best way forward; aggregation, affinity marketing programs, etc.

11. Town of Frisco

Timeframe: Q1/Q2 2016 Priority: E

- Comcast stated that they have an ongoing fiber project in town which can assist Frisco in connecting their government buildings.
- Interest by Frisco/Summit County business community in forming a LTPC. Jack Taylor and Rachel Lunney are working on this with Elevate.

12. Town of Red Cliff

Timeframe: CY 2016 Priority: A

- Red Cliff has submitted an application to the USFS for a communications site at Ski Cooper.
- NWCCOG, Red Cliff, ForeThought and Mammoth Networks are working with Ski Cooper, to use for ski lift terminal structures as mounting locations for poles to host microwave antennas for links from Red Cliff to Ski Cooper and Ski Cooper to Mosquito Pass.
- Construction on the Red Cliff tower is complete.

13. Town of Fraser

Timeframe: Q4 2016 Priority: A

- Fraser and Winter Park are working together on broadband sub-plan for both towns.
- Vantage Point Consulting is the consultant.
- Fraser and Winter Park met with Mountain Parks Electric to discuss their potential broadband plan and potential for partnership.

14. Town of Winter Park

Timeframe: Q4 2016 Priority: A

- Fraser and Winter Park are working together on broadband sub-plan for both towns.
- Fraser and Winter Park met with Mountain Parks Electric to discuss their potential broadband plan and potential for partnership.
- Mountain Parks Electric stated that their broadband business plan only works if more populated areas participate.

15. Town of Gypsum

Timeframe: Q4 2016/Q2 2017 Priority: A

- Gypsum is looking to leverage the 10 GB wave that Mammoth Networks installed earlier this year to support Eagle County. The fiber termination point is within the town limits.
- Forethought has purchased San Isabel Telecom. This may give the town more options and partner work with.
