The NWCCOG Foundation Board is asked to formalize the NWCCOG Foundation's administration fee policy.

The current unwritten policy is that the NWCCOG Foundation can charge a 7.5% admin fee to all funds passed through its account and the NWCCOG Foundation Board may choose to waive the fee or donate funds back to a project if the amount collected is more than the foundation needs to cover its costs.

Staff recommends the following policy:

All funding will be subject to a 5% administration fee to cover costs related to bookkeeping, annual independent audits, annual filing of form 990, and other staff time related to the on-going operation of the NWCCOG Foundation. Projects that require substantial NWCCOG staff time for fund raising or project management activities may be subject to additional charges to cover the Foundation's expenses for that project. The NWCCOG Foundation will waive administration fees for NWCCOG member jurisdictions and NWCCOG programs in situations that only involve passing through grant funds.
