#### **Call To Order:**

Karn Stiegelmeier, Chair, called the NWCCOG Council meeting to order at 9:34 a.m. Round table introductions were conducted, and a quorum was present

#### **Approval of Minutes:**

M/S/P Jeff Shroll/Brodie Boilard to approve the July 23<sup>rd</sup>, 2015 Council Meeting minutes.

#### July 2015 Financials:

Liz Mullen provided an overview of the July 2015 financials. She noted that these financials reflected only one month of activity, as the July 23<sup>rd</sup>, 2015 meeting covered May and June 2015. She again reiterated that the Loan Fund numbers reflect all loans as assets, which inflates the Loan Fund's revenues. However, the Loan Fund is doing quite well, and it is not operating on revolved funds.

Karn questioned why there was not a current balance on page 13 for loans 1, 4, and 13. Liz speculated that two of the loans had been paid off, and the businesses re-borrowed funds. The third loan may have just closed, without having drawn down funds. However, Liz acknowledged that Anita Cameron would have more specific information on this topic.

*M/S/P John Hoffmann/ Tom Clark* to approve the July 2015 financials as presented in the council packet.

#### **Program Updates:**

#### Alpine Area Agency on Aging (AAAA):

Jean Hammes provided an update on the AAAA. She stated that the SFY 14-15 ended June 30<sup>th</sup>, 2015. The most notable challenge for this contract year has been the selection of new providers. AAAA had to get approval of the Area Plan from the State, which did not arrive until June 29<sup>th</sup>, 2015. This delayed the process and timeline for contractor selection. A 7-member review committee oversees the contractor proposals, and a number of proposals were selected for clarification or resubmission. Due to these delays, the September meeting was canceled. Hopefully, final approval of proposals will occur at the November 4<sup>th</sup>, 2015 RAC meeting.

Alpine Area Retired and Senior Volunteer Program (AARSVP): C.J. Grove presented on the status and history of the AARSVP program. The Eagle Valley RSVP program was an opportunity presented to NWCCOG, when Eagle County no longer wanted to re-compete for the 3-year funding grant. Eagle County Public Health managed the program since 2000, and it is hopeful that the platform and structure of the previous Eagle County RSVP program could be expanded throughout the other 4 counties in the region. However, the current grant is only for Eagle County. It was decided to rebrand the program from Eagle County RSVP to AARSVP, as Eagle County volunteers were confused over the change in leadership and location.

State Health Insurance Assistance Program (SHIP)/Senior Medicare Patrol: T.J. Dufresne discussed her work with the SHIP/SMP program, recently re-acquired in July 2015. She is working on recruiting SHIP Counselors to provide better education and counseling opportunities for Medicare Eligible Individuals throughout the region. She is also expanding awareness of the program through community resources. T.J. participates as member of a nationwide Medicare rural outreach group, and she described how important local Medicare support is to our seniors, as calling the nationwide 800 number can be daunting.

#### **Broadband:**

Nate Walowitz stated that Red Cliff is moving along well, and he hopes to have broadband in Red Cliff by winter.

He is also working with Jackson County on a strategic plan. CenturyLink's current infrastructure will not allow purchase of bandwidth at a reasonable price. There also seems to be a disconnect between CenturyLink's Colorado team and the corporate offices. Currently, it looks as if CenturyLink will formally accept the CAF 2 funding today, which could assist matters.

Nate is also working with Kremmling to develop an alternative path for fiber to increase the bandwidth for Comcast and possibly allow a public Wi-Fi offering. Winter Park and Fraser are, also, working on a strategic plan. Rio Blanco County broke ground on their fiber project. Meeker and Rangely will be fully fiber enabled and will setup a network shortly. They are providing RFP vendor resources and references, which should benefit the region. Pitkin is also moving forward on their plans.

DOLA recently approved a grant to extend Nate's contract another 2 years, as well as an additional \$110K to provide statewide consulting. The consulting has proven beneficial for our region, as it allows for stronger networking opportunities and helps build better relationships with the State.

Many jurisdictions in our region are putting SB152 exemptions on the ballot, and discussions were held over the best way to inform the voting public about SB152.

#### **Elevator Inspection Program (EIP):**

The EIP program is making progress on 5-year witnessing requirements. Previously, NWCCOG was too short staffed to effectively meet this requirement; now elevator companies seem to be short-staffed. EIP is collecting cell phone numbers of mechanics in the field to facilitate coordination of these observations.

This spring, EIP hired 3 trainees. One, unfortunately, was not a good fit, so EIP is looking to refill that position. The other 2 trainees are doing an outstanding job and have eliminated any previous backlog.

Steve Allen, EIP Director, is doing an excellent job changing the culture of the elevator inspection program, from a traditionally adversarial relationship with elevator mechanics to one of cooperation. If there are minor deficiencies, that are not life-threatening, the inspectors contact the mechanics to review and correct the issues, prior to sending a report to the client.

#### Northwest All Hazards Emergency Management Region (NWAHEMR):

Kim Cancelosi is doing a superb job as the NWAHEMR Coordinator. She is currently working on the 2015 Homeland Security Grant Project, which expires next August. The only outstanding work for the 2014 grant is funding for meetings and the annual program audit. She is catching up on state strategic planning requirements and expects to be fully caught up by October.

#### **Northwest Loan Fund:**

The loan fund is booming under Anita Cameron's oversight. She has nearly expended her second round of funding, and she will soon be approaching Eagle County for additional funds. All loans are paying and everything seems to be going well.

#### **Regional Transportation Coordinating Council (RTCC):**

August 1<sup>st</sup>, 2015 was the first anniversary of the RTCC call center, and there has been great success. Two goals were set when RTCC was formed in 2011, setup the 1-click 1-call system for regional transportation and establish Non-Emergency Medicaid Transportation (NEMT) billing. Both goals were met, and RTCC will be looking for strategic direction during the October meeting. The RTCC program is currently seeking out other funding opportunities to supplement many grants that are set to expire at the end of 2015.

#### Water Quality and Quantity (QQ):

The QQ program, as NWCCOG, submitted comments on Denver Water's 401 Certification Application. There were many concerns regarding Denver Water's submission, including Denver Water's assertions of insufficient data and claims of credit for mitigation under the Colorado Cooperative Agreement.

#### Weatherization:

The Weatherization Program completed SFY 2015, on June 30<sup>th</sup>, 2015. They received \$1.2M to weatherize 155 homes, across 13 counties, 5 more than the goal of 150. Weatherization started a new contract cycle on July 1<sup>st</sup>, 2015, which includes funds that have not been fully allocated. The current goal is 126 homes, but this number will increase as new funds are allocated.

#### **Proposed Restructuring of Weatherization Program:**

There is a vacancy in the Weatherization Director position. NWCCOG proposes that instead of rehiring this position, which is expensive, NWCCOG would like to hire a Weatherization Program Specialist. This position would be the primary State contact, which is the State's only requirement for this role. The Weatherization Program Specialist would serve as an expert in all grant, budget, and procurement matters. This position would be part of a 3-member Weatherization Program Team that works in tandem with Intake, and Field Supervision, allowing for cross-training and coverage. The team would report directly to the Executive Director and would meet with Liz and the Fiscal Department monthly. NWCCOG would like to hire this position from within, so the new Program Specialist has in-depth knowledge of the nuances of NWCCOG's Weatherization Program.

With the savings from hiring a Weatherization Program Specialist, as opposed to a Director, NWCCOG proposes hiring another Weatherization Installer for the New Castle office. This office currently has only 2 employees, and this limits the work that can be completed, if there is an employee absence.

There was limited discussion regarding the proposal, which included a brief explanation regarding the vacancy in the Director position.

**M/S/P Suze Kanack/Ben Raitano** to approve the proposal to eliminate the Program Director Position and replace it with a Program Specialist Position and also add a new installer for the New Castle office.

#### **DISCUSSION: Future Growth and Direction of NWCCOG**

Liz presented a brief summary of NWCCOG's 3-year financial history, as well as services offered and programs. As a membership organization, Liz requested direction on the future vision of the NWCCOG organization. She reminded members that NWCCOG is at capacity for office space and indirect/administrative support, so those items would need to be taken into consideration in the future direction.

#### AAAA:

Discussion was held regarding the n4a final report for Community Living Services planning. The NWCCOG received funding from DOLA to investigate developing a fee-for-service program, which would include cultivating the organizational capacity to win contracts with hospitals, medical providers, as well as Medicaid, Medicare, and private insurance. It is anticipated implementing a fee-for-service program would require the hiring of a Community Living Services Director/Business Developer to oversee this process. Opportunities for moving forward with this plan include designing a program that suits the region's needs, as opposed to having a program directed by State or Federal agencies. It would also allow for diversification of funding, and the ability to organize and

recruit providers to meet the region's unique needs. Finally, this program has the potential to streamline service delivery and yield cost savings. Failure to move forward with this plan could allow another organization to step into this role, potentially compromising the efficacy of the Alpine Area AAA.

Members discussed the tumultuous health care environment and acknowledged that NWCCOG would be unable to "fix the current health care system." The Board also discussed that a consultant with the in-depth knowledge of the healthcare contracting system and language would be an outright investment at this time, but parallels were drawn to the success of the Broadband program under Nate's expertise.

Permission was requested to explore the opportunities where NWCCOG could have a seat at the table of the evolving regional health care climate, and a reminder was made that small counties would rely on NWCCOG to be an expert in this role, as they would be unable to afford a consultant on their own. Nate further remarked that NWCCOG provides extraordinary membership value within niche services.

Liz informed the Board that the models presented in the board packet are being put into practice in urban areas, and it makes it difficult to envision what our version would look like. The board was reminded that it could take a year to obtain a Medicare number, and Medicare/Medicaid reimbursements are poor and generally require subsidization. However, with a Medicare number, AAAA could receive reimbursement for services already being provided, such as diabetes self-management classes, which would diversify funding opportunities.

However, Liz further intimated a conversation held with a new regional health care player explaining that they prefer to contract with their providers directly, without an intermediary, and they require providers who are willing to serve patients from cradle to grave, not just seniors.

Board members felt it important to gather information from other AAAs already considering this direction, including Boulder and DRCOG to investigate what NWCCOG's role may be in the future. It is hoped that these agencies can provide guidance on their experiences and visions. Jean, Liz, and James Newberry hope to schedule a meeting with these agencies and bring the information back for the October 2015 meeting.

#### **Regional Project for 2016 DOLA EIAF Grant Application:**

NWCCOG applies for DOLA Energy and Mineral Impact Fund Grants annually and is typically awarded \$50,000, requiring a dollar-for-dollar match. NWCCOG sought direction on regional projects to propose for this funding.

Rachel Lunney requested to utilize a portion of this potential funding for her Comprehensive Economic Development Strategy (CEDS) project, due December 2016. The EDA requires that a CEDS be completed every 5 years in order to maintain funding. CEDS is designed to be an economic development tool for a number of audiences. Rachel proposed creating an interactive website component to the upcoming CEDS that has more updated, valuable information and serves as a

marketing tool for our region. She anticipated that this project would necessitate around \$25,000 with matching funds coming from current EDA funding.

The board agreed that this would be an ideal project to propose for the DOLA grant and recommended adding an app, as well as ensuring that the page is optimized for mobile viewing.

The Council further discussed other regional projects to propose for the remaining \$25,000, which included a debate on regional projects vs. mini-grants. Topics included affordable housing, hospice services, substance abuse detox, and mental health. However, final decision was to utilize funds to update the Senior Gap Analysis to help direct the focus of future endeavors.

**M/S/P Patty McKenny/Suze Kanack** to apply for DOLA funds for the online CEDS project and to update the Senior Gap Analysis.

#### <u>DISCUSSION: Review of NWCCOG's Technical Assistance Grant Process and Guidelines:</u>

As the Board decided against mini-grants. This discussion did not take place.

#### **Member Updates:**

**Karn Stiegelmeier, Summit County:** The Town of Breckenridge and Vail Resorts will partner with Summit County to supplement the increased county match for the CDOT RAMP project outside of Frisco. This project will move forward next year. Summit County is working on a devolution project from CDOT on the Vail Pass recreation path from the top of Vail pass to Copper Mountain.

James Newberry, Grand County: Grand County recently had the Middle Park Fair and Rodeo, and the Demolition Derby was also a success. Budget is beginning, and everything looks flat. Sales tax is up throughout the county, and contractors are busy again. Finally, County Manager Lurline Underbrink-Curran is retiring. She was instrumental in many water dealings, helped guide the county to be debt free, and she has been a dedicated advocate of Grand County. She will be missed.

**Tom Clark, Town of Kremmling:** The Highway 9 project is going well, and it seems to be on schedule. One underpass has been completed. June sales tax is the highest ever. This is fortunate, considering all of the construction on Highway 9. Kremmling will receive new signage to inform tourists of amenities and sidewalks are being improved. Despite rain, the Fair and Demolition Derby saw over 3,000 attendees.

Jeanne McQueeney, Eagle County: Ground was broken on the new senior housing project, and Eagle County has started strategic planning to determine priorities. There are many complex issues in Eagle County like housing and childcare, as well as ensuring that the planning takes into account the Hispanic community. The Fair and Rodeo went well, and it is a great example of how Eagle County integrates the entire community into an event. The strategic plan will also examine sustainability, energy, and climate change needs.

**Valarie Blevins, Town of Red Cliff:** Red Cliff is moving forward with Nate's help on broadband. The town is getting its finances in order and is looking to make future infrastructural improvements.

**Brodie Boilard, Town of Frisco:** Frisco is doing well. Sales tax is up, but things are starting to slow down. Phase 3 of the 4-phase Main Street project is beginning. This project can be disruptive for merchants and tourists.

**Suze Kanack, Town of Walden:** The schools, the Town of Walden, and Jackson County partnered to improve the road circling the park and the schools. The schools were able to leverage federal funding to make these improvements.

**Patty McKenny, Town of Vail:** Vail enjoyed a robust summer, and sales tax is up 5% over the prior year. The budget will be presented on September 1<sup>st</sup> 2015, with projected increases for revenue and wages. Improvements were completed on Ford Park, and there were many successful cultural and athletic events. The Betty Ford Alpine Garden Education Center opened at the end of July. Vail will be hosting CAST tonight and tomorrow, and Vail has entered into a sisterhood agreement with San Miguel de Allende in Mexico and is looking forward to that collaboration.

**Jeff Shroll, Town of Gypsum:** Sales tax for Gypsum is up slightly. A DOLA grant was received for a new gun club facility including a clubhouse and event center. Soon, CDOT will no longer provide services on Highway 6 between Gypsum and the Town of Eagle, as these communities have partnered with CDOT on a devolution of this road. Finally, Gypsum is getting ready to submit their budget.

## PROGRAM UPDATES

**Re:** October 2015 Program Updates

The following are the events of note that have occurred since the August 27<sup>th</sup>, 2015 NWCCOG meeting.

## Alpine Area Agency on Aging (Alpine AAA) – Jean Hammes, Director Region 12 Regional Advisory Council–

#### **Subcontractor Contracting**

The Review Committee completed their review, evaluation, and scoring of the subcontractor proposal responses. Their funding recommendations will be presented to the Regional Advisory Council at the Council's November 4, 2015 meeting. Upon action by the Regional Advisory Council, contracts will be issued to the selected awardees on November 5, 2015.

As part of the contracting process with the approved awardees, an on-site assessment for contract and service delivery readiness will be scheduled and completed from November 9<sup>th</sup>-November 30<sup>th</sup>, 2015. In addition, the CDHS Subcontractor Approval Form will be submitted to the State Unit on Aging. The SFY 2015-2016 service contracts will need to be signed and executed no later than December 23<sup>rd</sup>, 2015 (revised from the last program update) for the initial contract period of January 1<sup>st</sup>, 2016 to June 30<sup>th</sup>, 2016.

#### **Program Operations**

<u>SFY 2016 Contracts.</u> The service agreement between the awarded service providers and the NWCCOG-Alpine Area Agency on Aging is under revision. Staff is comparing the required contract items with the State Unit on Aging to the NWCCOG contract. NWCCOG's legal counsel will further review the revised document prior to issuance to subcontractors.

#### **Legislation & Advocacy**

Aging Policy and Advisory Committee (APAC). The initial reading of the revised Volume 10 regulations (12 CCR 2510-1) completed through APAC, was heard at the State Board of Human Services on October 2<sup>nd</sup>, 2015. Minor revisions were suggested; the final reading will be on November 6<sup>th</sup>, 2015. Policy items under consideration: Senior services data study, data collection for the performance measures and outcomes in the SFY 2015-16 state contract with area agencies on aging, review new final regulations for the LTC Ombudsman Program— and as needed revise—policies and/or practices, prior to the implementation date, July 1, 2016

#### **Other Information**

The Region 12 ADRC [Aging & Disability Resources for Colorado] has been invited to partner with the Summit County Respite Coalition to create a respite model in the county. This pilot project would eventually be replicated throughout the region. The Region 12 ADRC would work with the respite coalition to submit a Special Initiative grant and use some of this funding to support a contract position to develop and implement

respite in the community. We discussed this opportunity with some of the core Region 12 ADRC members, and they believed the Region 12 ADRC is in a good position to work on this project.

### <u>Alpine Area Retired and Senior Volunteer Program (RSVP) –</u> C.J. Grove, NWCCOG Volunteer Program Coordinator, RSVP Program Director

Service activity statistics for July-September 2015

- o 30 volunteers served 2176.42 hours garnering donations for nonprofit organizations
- o 1 volunteer served 14 hours building homes for Habitat for Humanity
- o 8 volunteers served 347.00 hours working in education programs
- o 5 volunteers served 71.75 hours working to preserve At-Risk Ecosystems
- 11 volunteers served 193.50 hours coaching, distributing Medicare information, providing fraud prevention information and receiving training to help older adults with access to care
- 33 volunteers served 748.50 hours providing companionship, food delivery and transportation to older adults to assist them in aging in place
- 8 volunteers served 222.25 hours garnering food donations for food banks and distributing food to homebound individuals

The RSVP program is currently working to develop the "Helping Hands for Seniors" program to provide minor home repair, modifications, and chores for older adults, individuals with disabilities, and veterans.

CJ Grove met with an organization in Eagle County who utilizes volunteers to provide snow removal for Seniors, and the Alpine Area RSVP is working on a partnership with this organization to serve more Eagle County seniors.

The RSVP program is also exploring ways to expand some of the volunteer programs to other counties, and the program is currently looking into partnerships and grants to help fund these services.

## <u>State Health Insurance Assistance Program (SHIP)/Senior Medicare Patrol (SMP)</u> –T.J. Dufresne, Health Insurance Assistance Coordinator

The SHIP Medicare Counseling program is preparing for the Part D annual Open Enrollment Period (OEP,) which runs from October 15<sup>th</sup> 2015 – December 7<sup>th</sup> 2015. This will be a busy time for the certified SHIP Counselors. There are now 11 trained volunteers, who are able to assist Medicare beneficiaries. This is up from 6 volunteers, as of July 2015 and the program's inception.

The recruitment of new volunteer SHIP Counselors has been a challenge. With the help of the RSVP Coordinator, C.J. Grove, two new certified counselors are now helping Medicare beneficiaries in Eagle County. Two additional volunteer SHIP counselors have been trained to meet with Medicare Beneficiaries, and they will complete two additional certification-training days after open enrollment. (The State has chosen not to conduct training session during the open enrollment period, due to capacity issues.)

Volunteer SHIP Counselor recruitment efforts have been successful, and the SHIP/SMP program will be able to expand assistance capacity post OEP. There are five more volunteers scheduled to go through training offered after December 7<sup>th</sup>, 2015. The volunteer recruitment efforts have consisted of visits to

meal site programs, senior center engagement, public forums, and networking with faith-based organizations and other community anchor resources. Public library locations in all five of our counties have welcomed the program and provided space for meetings.

Education and outreach efforts have also been underway. In addition to recruitment of volunteers, the SHIP/SMP program has provided overview presentations of Medicare and fraud prevention. The goal of the first round of presentations has been to build trust and awareness among partners and beneficiaries. The goal has been to inform communities that our area has more access to Medicare enrollment and information assistance locally.

The SHIP Coordinator, T.J. Dufresne, has received many calls for assistance. T.J. is testing different logistical management of the calls, in order to effectively and efficiently handle the demand for assistance. Unfortunately, South Central Medicare calls have been incorrectly routed to the mountain assistance site, which has added to call volume. Where appropriate, those calls are referred to the proper SHIP office.

T.J. has already seen great success in assisting Medicare beneficiaries. She has assisted with claim appeals, enrollment in Medigap and Advantage plans for new enrollees, and prescription needs management (helping beneficiaries select the best prescription drug plan - Part D plans) and she has assisted beneficiaries in obtaining financial assistance for expensive drugs. Medicare beneficiaries have expressed significant gratitude for the assistance and local availability.

#### **Broadband Projects** – Nate Walowitz, Regional Broadband Coordinator

Below is a summary of the decisions made by NWCCOG's participating jurisdictions regarding a November 2015 Ballot Referendum related to a SB-152 Exemption:

- Town of Fraser On November ballot

- o Town of Red Cliff Previously passed in November 2014
- o Town of Winter Park On November ballot
- o Town of Yampa On November ballot
- o Colorado Mountain College (in multiple counties) On November ballot

NWCCOG continues to engage with CenturyLink to schedule meetings with individual counties and local governments. By late November, CenturyLink will have held CAF II initial meetings with all our Counties and interested local governments. Nate worked with DOLA and released a map of covered areas, and spreadsheets of location counts per county and total funding by county.

In Calendar Year 2015, NWCCOG Broadband Initiatives have resulted in \$ 4,595,000 in DOLA Grant money to the region.

The Grand County Economic Development Committee is moving forward with forming a committee to create a broadband sub-committee. This team will work to develop a strategic plan RFP and a DOLA grant application. Focus will be how to support public/ partnerships to improve last mile deployment to unserved and underserved areas.

The Town of Craig will be submitting an application in October to DOLA for a grant to fund development of a strategic plan.

Pitkin County released their RFP for a broadband network in Pitkin County. It will be a multi-use fiber/wireless broadband loop connecting all their mountaintop sites for broadband deployment, public safety communications and County IT network redundancy. Pitkin County hired Jeff Krueger as their Communications site manager. Kara will be transitioning the broadband, VHF – DTR conversion, and translators to Jeff. The County is moving their public safety radio system from a County owned VHF system to the State DTR (800 trunked radio system). This migration will incorporate the development of new and existing radio sites and tower locations with the State of Colorado. These efforts will also support the deployment of future fiber and microwave broadband networks throughout the County.

Routt County received a DOLA broadband administrative planning grant. NeoFiber is their consultant. A DOLA grant application was submitted for fiber extension to connect County Justice Center and Yampa Valley Electric Association to the NCB CNL.

Red Cliff is working to finalize paperwork to acquire Battle Mountain half of tower site property. COMNET Cellular is interested in putting a cell site on Red Cliff tower, thus a NEPA process has been started. Permanent tower and services will not be constructed and available until summer 2016. The USFS has declined a temporary site application from HCI/Forethought at Ski Cooper. All parties met with USFS in late September and a new application is being submitted with emphasis on getting an approval for Ski Cooper site by early next summer.

Towns of Winter Park and Fraser have SB-152 exemption on November ballot. A public WiFi network project for Main Street will be part of a strategic plan, which is targeted for development in 2016. Local ISP is building access to 2+ GB of data for distribution in the region. They have reached out to other local ISPs, towns, schools and communities for end user/resale agreements.

#### Economic Development District (EDD) — Rachel Lunney, Director

The SBDC Women's Business Conference was held on October 9<sup>th</sup>, 2015 in Vail, and it was a great success. NWCCOG was a sponsor of this event, and there were over 300 attendees.

Rachel Lunney attended the Rocky Mountain Workforce Development Association's conference on October 5<sup>th</sup>, 2015. The conference allowed planning time for workforce development board members to provide input

on new developments enacted through recent legislation. This new legislation (Workforce Innovation and Opportunity Act (WIOA)) will govern how workforce dollars are utilized within the state and regional workforce system.

On October 21<sup>st</sup>, 2015, Rachel will attend the Rural Resort Region Workforce Development Board. She will also attend the Winter Park/Fraser Chamber of Commerce Business Expo on October 21<sup>st</sup>, 2015 and represent both the EDD and the Northwest Loan Fund.

The WorkWell Collaborative Advisory Committee (an initiative of the Regional Health and Wellness Sector Partnership) met on October 8<sup>th</sup> 2015. To date, Health Links Advisors have been hired in 4 out of 5 counties. (Grand County is still recruiting an advisor). Employer trainings have been set up for October 21<sup>st</sup>, 2015 in Summit County; November 3<sup>rd</sup>, 2015 in Pitkin County, and November 4<sup>th</sup>, 2015 in Eagle County.

NWCCOG is serving as a convener to send a regional team to attend the Colorado Workforce Development Council's Sectors Academy (CWDC) November  $5^{th} - 6^{th}$ , in Denver. This will be an opportunity for our regional team to work on our health and wellness sector partnership, as well as plan for future industry partnerships. CWDC is providing travel scholarships to regional teams.

The next EDD working group meeting will be held on October 28<sup>th</sup>, 2015 at EVO3 Co-Working space in Frisco. At this meeting, the results of the kitchen business incubator feasibility study will be presented. A Rural Economic Development Initiative grant from DOLA funded this study, and it was conducted by the SBDC.

#### Elevator Inspection Program (EIP) — Steve Allen, Director

The Elevator Inspection Program (EIP) has remained current with annual inspections, while increasing the number of 5-year witnessing tests. EIP is also current on new construction and modernizations. The program is looking at the imminent weather conditions and preparing the program vehicles accordingly.

EIP has also created a plan to promote compliance with NWCCOG and OPS's safety requirements. The plan is as follows:

Presently OPS guidelines require that conveyances given a void certificate when inspected be required to correct those deficiencies within 90 days. If corrections are not made, the deficient conveyance (elevator, lift, escalator, etc.) is to be shut down. Calls to the responsible party to notify them when there are only 30 days remaining to comply have not produced adequate responses. There are two reasons that explain the majority (if not all) of non-compliance incidents:

- 1) Responsible party is not actively participating in the correction of deficiencies.
- 2) Elevator maintenance companies are inadequately staffed to provide the necessary service.

The mountain areas seem to be affected by situation (2) to a greater extent than the less difficult areas to travel and maintain staff. The conveyance maintenance company works for the conveyance responsible party. The responsible party is held accountable for ensuring that conveyance maintenance companies meet their maintenance obligations. Steve Allen has proposed a procedure that would address both situations:

The EIP program will send out an email similar to the one below, with a CC to the appropriate building official.

"The elevator at xxxxxxx Serial #xxxxx was issued a void certificate on xx/xx/xxxx. It has 30 days left from that date to achieve compliance. Compliance must be achieved by xx/xx/xxxx and NWCCOG notified with a signed affidavit from a state licensed maintenance company. (Forms are available on the NWCCOG website.) This is the responsibility of the conveyance responsible party. If the conveyance is not in compliance at the 60-day mark, a fine will be levied (as per previous notification) of \$75.00 per day.

In order to achieve a valid certificate after the 60-day mark, both the affidavit confirming compliance and the levied fine requirements must be satisfied. If compliance is not met within 90 days, the elevator will be removed from service, until all requirements are met, per the Colorado conveyance program requirements."

As stated in the proposed NWCCOG communication, all responsible parties will be made aware of this policy before it is put into effect. The intent is to bring about compliance while maintaining a healthy economic environment (i.e. Not shutting down the elevator.) NWCCOG recognizes that this is a variation on the typical approach to compliance. EIP prefers to use the first enforcement opportunity to levy a reasonable fine, instead of taking the conveyance out of service. Steve Allen has conferred with the Colorado Department of Labor and Employment and the EIP Advisory Committee and received a positive response to the above change.

#### **Energy Management (Weatherization)** – Liz Mullen, Executive Director

There have been several changes in the Weatherization program. Nate Speerstra has accepted the Weatherization Program Specialist position and is working closely with the Colorado Energy Office (CEO) and NWCCOG's fiscal office to become familiar with the weatherization grants, budget, and administrative processes. Nate has worked for NWCCOG's weatherization program since 1999, has a strong background in weatherization, and a clear understanding of what is needed to make our program successful. Nate's years of experience will help our program become more efficient and effective.

Sean O'Connell reluctantly left weatherization at the end of August to move out of state and Mark Hox has been promoted to the Auditor position. Mark has worked for NWCCOG's weatherization program since 2008 as an installer and a trainer. These promotions have left two installer position vacancies in the Silverthorne location. As of October 15<sup>th</sup>, Spence Alley has been hired to fill one of the Silverthorne installer positions. We continue to search for candidates for the remaining Silverthorne and New Castle installer positions.

Bob Wyler generously offered for the weatherization program to rent a larger bay recently vacated by Comcast with no increase in our monthly rent, so the weatherization team moved all of their supplies and equipment to the new bay in September. This was an excellent opportunity to complete some much needed purging and cleaning.

Even with being under-staffed and with the move to the new bay, the weatherization team completed 27 homes and is within three units of their production target for the first quarter of the new grant, which began on July 1.

## Northwest All Hazards Emergency Management Region (NWAHEMR) – Kim Cancelosi, Coordinator

The 2014 grant is still open for Coordinator time and meeting expenses. Both the Region and the State have signed the 2015 grant contracts, and purchasing of equipment is about to take place. The Region updated and submitted the first three steps of the Regional Threat Hazard Identification Risk Assessment (THIRA) Plan to the State. The final step of this process is identifying gaps in the region when responding to a threat or hazard. Additionally, the Region submitted the Regional Homeland Security and All-Hazards Strategic Plan.

On October 1, 2015, a regional training workshop was held in Rifle on the Dragonfly/Salamander credentialing system. The Summit meeting for all groups interested in submitting project proposals for the 2016 grant is set for November  $10^{th}$ , 2015 in Rifle at the Sheriff's Annex building.

The Colorado Department of Homeland Security is planning to conduct a monitoring visit to our region before the end of 2015.

#### Northwest Loan Fund (NLF) - Anita Cameron, Director

Since the last Council meeting, two more loans have closed and been funded. The NLF has loaned in 7 of the 9 counties that we serve. Eagle County wrote, on our behalf, to the State to request an additional \$650,000 in grant funds. This will go to the State Loan Committee on October 28<sup>th</sup>, 2015. Calls continue and many are encouraged to submit applications. A repeat customer applied for additional funds.

The Loan Committee meets twice a year in person and just met at Rocky Mountain Pizza in downtown Glenwood Springs. Seven members completed two-year terms and have committed to stay on our team.

For marketing and visibility, the NLF attended a Craig Chamber of Commerce Mixer, events in Grand County, and the 6<sup>th</sup> Annual Women's Conference in Vail.

## <u>Regional Transportation Coordinating Council (RTCC)</u> – Susan Juergensmeier, Mobility Manager

The RTCC Mobility Management effort has been recognized as one of the leading rural mobility management projects in Colorado. The RTCC achieved the initial goal set in 2010 to establish a One Call/One Click transportation resource center and set up a regional Medicaid billing system. In September, Susan Juergensmeier participated on a panel about our Non-Emergent Medical Transportation (NEMT) Medicaid Broker/Billing project at the Colorado Association of Transit Agencies (CASTA) conference. She has also been asked by the Community Transportation Association of America (CTAA) to participate on a Mobility Management panel at the Rural Transportation Assistance Program (RTAP) National Conference, in Denver on October 28<sup>th</sup>, 2015.

Now that the initial goal has been achieved, the RTCC held a planning session at their meeting on October 7<sup>th</sup>, 2015 to look toward future projects and insure the sustainability of the Mountain Ride (One Call/One Click) Transportation Resource Center and the NEMT Billing project.

The NWCCOG Foundation, Inc. has received the final approval for the RTCC profile to be included on the Colorado Gives website. This year, Colorado Gives Day will be on Tuesday, December 8, 2015. Donations are requested to fund rides for veterans, senior citizens, low income individuals, and people with disabilities through the Mountain Ride Transportation Resource Center. CDOT released a Notification of Funding Availability for Local Coordinating Council grants for 2016. The RTCC will apply for funding to support the Regional Transportation Coordinating Council. Applications are due November 13<sup>th</sup>, 2015.

The Mountain Ride Transportation Resource Call Center is continuing to be in demand. Most trips coordinated and booked to date are part of the regional Non-Emergent Medical Transportation (NEMT) Medicaid billing project.

As of September 30<sup>th</sup>, 2015 the Call Center booked over 3,070 rides for 2015. The following statistics outline the number of one way trips by each county:

- o Eagle 551 trips
- o Grand 734 trips
- o Jackson 18 trips
- o Pitkin 258 trips
- o Routt 953 trips
- o Summit 556 trips

In addition to booking trips, the Call Center staff has provided referrals to our transit partners in our entire RTCC seven county region, including RFTA and the Traveler in Garfield County.

The next Regional Transportation Coordinating Council (RTCC) meeting will be held on December 2<sup>nd</sup>, 2015.

Water Quality and Quantity Committee (QQ) — Lane Wyatt and Torie Jarvis, Co-Directors
The next board meeting for QQ is scheduled for October 21<sup>st</sup>, 2015 in Silverthorne, at the North Branch Library.

QQ is participating in several rule makings through the Water Quality Control Commission. In the next few months, QQ will be participating as a party in updates to Regulation 93, the list of impaired waters under Section 303(d) of the Clean Water Act. Over the next year, QQ will continue to monitor proposed changes to Regulation 31, the basic standards, and methodologies for surface water quality in the State.

NWCCOG Watershed Services and QQ initiated a facilitated process to determine an attainable clarity standard for Grand Lake. The process is ongoing, so QQ will report more on the progress at a later time.

Participation continues in Learning by Doing, an adaptive management strategy for stream health and restoration in Grand County, in partnership with Grand County and Denver Water stakeholders. The group is planning a stream restoration project to be completed by the end of 2015.

Work continues on the Colorado Water Plan. QQ submitted comments on the second full draft of the Plan in September. This was the final opportunity for public comment, and the Plan will be finalized by December of this year. QQ is monitoring a new rule making at the Oil and Gas Conservation Commission, based on the recommendations from the 2015 Governor's Oil and Gas Task Force. A draft rule was published recently, and a stakeholder process to gather input is beginning. More information on this rule making can be found <a href="https://example.com/here">here</a>.



#### "Prepping" our Forests to Minimize Impacts of Wildfires on Communities

Wildfire is an increasing threat to communities throughout the Western United States. Many of us living in the high hazard "red zone" are concerned that Congress has failed to adequately address this issue. Now two Western senators have stepped forward to take action. The Colorado Bark Beetle Cooperative (CBBC) is heartened by the bipartisan leadership of Senators Michael Bennet and Mike Crapo. They recently introduced the "Prepare, Ready, Equip, and Prevent Areas at Risk of Emergency Wildfires 6 Act of 2015" or the "PREPARE Act of 2015".

Currently over 50% of the US Forest Service budget is needed to fight catastrophic wildfires, leaving insufficient funding for planning, collaboration, fuel reduction and other measures to reduce wildfire impacts. This critical legislation establishes a wildfire mitigation pilot program that would fund hazardous fuels reduction identified in community wildfire protection plans, mitigation efforts against flood damage, investments in equipment and personnel, and community planning efforts.

CBBC supports communities to become more resilient through collaborative efforts that could utilize some of the anticipated funding. These efforts can include fuels treatments where they are most effective and designed with input from the community, infrastructure protection, as well as, preparing communities for post-fire impacts. The act provides for support from the National Predisaster Mitigation Fund for not less than \$20,000,000 and not more than \$30,000,000 for each of fiscal years 2016 through 2021

"The funds may be used to reduce the hazardous fuel load by reducing the use of fuels that may contribute to catastrophic wildfires in high-risk areas; to invest in personnel and organizations to

conduct wildfire mitigation; to invest in vehicles and other equipment to conduct wildfire mitigation; to mitigate against damage from runoff into waterways and floods caused by erosion from wildfires; to build essential community collaboration and outline the necessary groundwork systems in anticipation of future fires."

Let's all get behind this important legislation and thank Senators Bennett and Crapo for stepping up and addressing this critical need.

The CBBC is a place-based collaborative created in 2006 to address the environmental, social, and economic impacts of the mountain pine beetle epidemic and has since reorganized to focus on increasing community resilience to natural disturbances in the high altitude forests of Central Colorado. The Steering Committee is comprised of federal, state, and local government representatives, along with representatives of public utilities, water providers, wood products industry, conservation, and public interest groups.
