The Colorado Department of Health Care Policy and Finance (HCPF) has set up a stakeholder meeting for non-emergency transportation (NEMT) providers to discuss the statewide NEMT

brokerage, which is planned to go into effect July 2025. NEMT providers are encouraged to attend and give their input on the proposed changes.

HCPF was also able to extend deadlines for NEMT recredentialing. The extended deadlines are located in this **Provider Bulletin**. See page 30 for the complete write-up; however, it states that agencies have until August 14, 2024 to get through the credentialing process. The credentialing requirement is only for providers who are currently enrolled as a type 73 (NEMT) provider.

### FTA Competitive Funding Opportunity

FTA **announced** an FY 2024 Competitive Funding Opportunity: Enhancing Mobility Innovation. Funds will be awarded for projects that advance emerging technologies, strategies, and innovations in traveler-centered mobility. Applications are due August 30, 2024. Projects will focus on innovative service delivery models, creative financing, novel partnerships, integrated payment solutions, and software solutions that facilitate the provision of

integrated demand-response public transportation service that dispatches public transportation fleet vehicles through riders' mobile devices or other means.

## Survey on Active Transportation

CDOT has released a new survey to help inform the goals and priorities of the forthcoming Statewide Active Transportation Plan. This new plan sets the stage for enhancing biking and walking throughout Colorado and embraces statewide momentum around active transportation investment. The Plan will include goals, policy recommendations, interagency collaboration, and a comprehensive process for evaluating and prioritizing projects which will improve safety, equity, mobility, connectivity, and sustainability across our transportation system. The Active Transportation Plan will also inform the Statewide Transportation Plan, which guides Colorado's overall transportation vision and investment priorities. The survey should take about 5-10 minutes and asks about walking and bicycling habits, preferred pedestrian and bicycling facilities, and barriers to walking and biking. The survey is available in **English** and **Spanish** and will be open through July 31, 2024.
